Town Line Road between White Bear and New Canada. Filed in my office this 5th day of May 1883.

Town Line Road Order between the towns of White Bear and New Canada, State of Minnesota, County of Ramsey, Town of White Bear, SS:

Whereas, upon the petition of more than twelve legal voters, owning or occupying real estate within one mile of the road proposed in said petition to be laid out, copies of said petition having been first duly posted up in three of the most public places of said towns at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit, which said proposed new road is set forth and described in said petition as follows, viz:

Beginning at a point on the County line between the Counties of Ramsey and Washington, where the Township line of the Townships of White Bear and New Canada intersects said County line, Thence West along the said Township line of White Bear and New Canada or as near said line as practicable to where the County road known as the St. Paul and Center-ville Road in sections thirty-three (33) and four (4) crosses said Township line.

And whereas, upon receiving said petition we did within thirty days thereafter make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit:

On the 13th day of April A.D. 1883, at the house of August Raditz, causing copies of such notice to be posted in three public places in said town, at least ten days previous to such meeting; and having met at such time and place as above named in said notice, and being satisfied that the applicant had at least ten days previous to said time, caused such notice of time and place of hearing to be given to all the occupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown by affidavit we proceeded to examine personally such highway and heard any and all reasons for or against laying out of the same, and being of the opinion that such laying out was necessary and proper and that the public interests would be promoted thereby we granted the prayer of the petitioners, and determined to lay out said road, and caused thereof a survey to be made according to the report and plat accompanying the description of which as so laid out is as follows, to-wit:

Beginning on the Town line between Township twenty-nine (29) and thirty (30) North, Range twenty-two (22) West at the Northeast corner of section one (1) Township twenty-nine (29) North, Range twenty-two (22) West; the same being also the Southeast corner of section thirty-six (36) Township thirty (30) north, Range twenty-two (22) west and running thence west along said Town line, (being the line between the Towns of New Canada and White Bear) to the intersection with the center of the Centerville Road at a point on said town line 10.26 chains West from the quarter section corner between section four (4) Township twenty-nine (29) north, Range twenty-two (22) West and section thirty-three (33) Township thirty (30) North, Range twenty-two (22) West.

It is therefore ordered and determined that a road be and the same is hereby laid out and established according to the description last aforesaid and the report and plat accompanying which is hereby made a part of this order, and it is hereby declared to be a public highway four (4) rods wide the said description above given being the center of said road.
