RAMSEY COUNTY TOWN OF WHITE BEAR SS.

Whereas, upon the petition in writing, of twelve (12) freeholders residing in said town, a copy of their petition having been first duly posted, as required by law, we, the Supervisors of said town, did on the 6th day of July, A. D. 1872, personally examine the route of the new road proposed in said petition, to-wit:

Commencing at Birch Lake at a point where the quarter line of Section 15 crosses said lake on the South Shore thereof, thence South on said line, or as near said quarter line as practicable to the county road West of Goose Lake, and West of L. S. & M. R. R. and having, before determining to lay out said road, fixed upon a time and place when and where we would meet to hear any reasons for or against the laying out of the same, and having caused written notices thereof to be posted up in three public places near the line of said road tem days previous to the time of such meeting, and having met at the time and place appointed for hearing such reasons, and having heard such as were offered, and being of the opinion that such laying out of the said road is necessary and proper, and that the public interest would be promoted thereby, and havinggranted the prayer of said petitioners, and determined to lay out the said road, we did, on the 2nd day of August A. D. 1872, cause a survey thereof to be made by a competent surveyor, who made report to us, as follows, to-wit:

To the Supervisors of the Town of White Bear in the County of Ramsey, and State of Minnesota:

The undersigned having been employed by you to make a survey of a road beginning at the Southeast shore of Birch Lake at a point where the quarter line of Section fifteen (15) intersects said shore; thence South on said quarter line, or as near said line as practicable, to the county road West of Goose Lake and West of L. S. & M. R. R. in Section 22, and I certify that herewith is a correct plat of said survey, and that below is a correct plat of said road, according to said survey.

It is, therefore, ordered and determined that the said road be and is hereby laid out and established according to said survey, and the plat hereunto annexed and made part of this order, which road is hereby declared to be a public highway four rods wide, the line of said survey being the center of said road.
