Commissioner Blank reported on her attendance at a meeting with officers and members of the Legislative Committee of the State Association of County Commissioners and Executive and Legislative Committee of the County Engineer's Association as to procedure and the possible factors involved in connection with working out a proper formula for distribution of the Gas Tax License Fee which the Interim Committee is about to take up.

She stated that although the meeting was ostensibly to consider this problem the main point of discussion has been the forming of an organization such as the League of Minnesota Municipalities of counties of the State.

She said it had been the unanimous opinion that such an organization was needed and it was decided that the counties would need an Executive Secretary to perform the duties similar to that performed for the League of Minnesota Municipalities by Mr. Ludwig and be prepared to lobby for the counties in the 1957 Legislature. It had been decided that the sum of \$15,000.00 for expenses should be set up to be provided by contributions from the counties on the basis of \$150.00 by counties receiving 1% of the gas tax, \$300.00 by counties receiving 2% and \$450.00 by counties peceiving 3%. Under this plan the County of Ramsey would be required to contribute \$450.00 as would Rennepin County and St. Louis County.

Chairman Dillon expressed the opinion that Ramsey County would not particularly gain by a reallocation of gas tax fund.

Commissioner Blank pointed out that the County's subdivision would stand to gain somewhat. (1622) Commissioner Goodrich introduced the following resolution and moved its adoption, seconded by Commissioner
