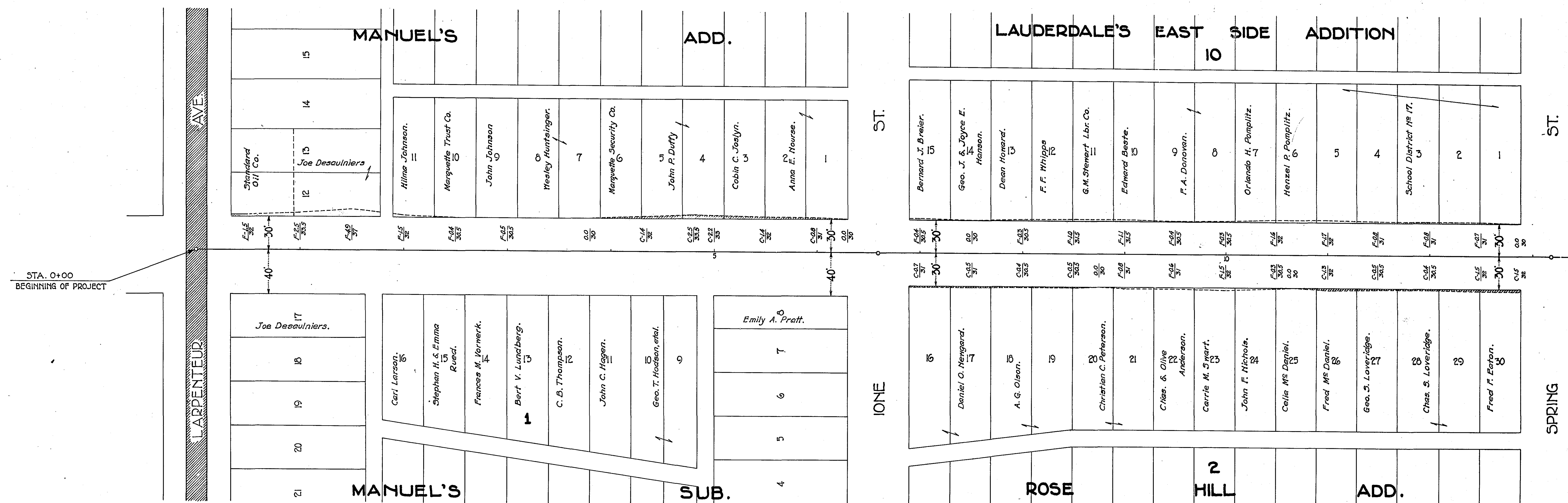
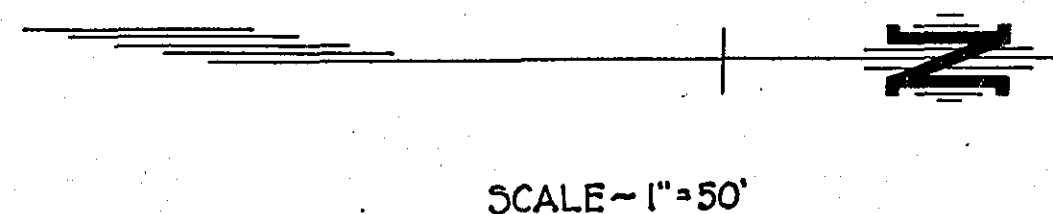


EUSTIS STREET
