

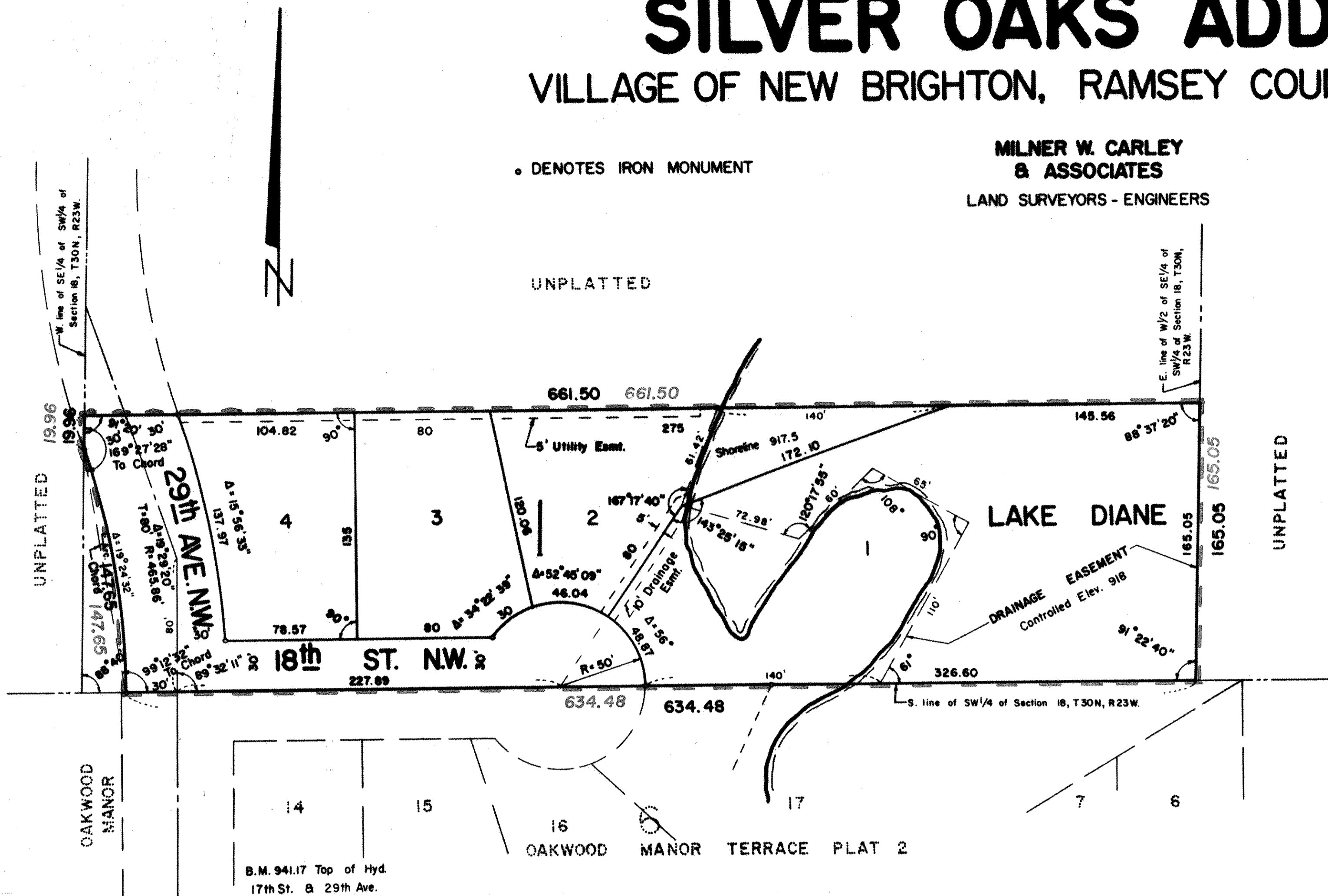
# SILVER OAKS ADDITION
