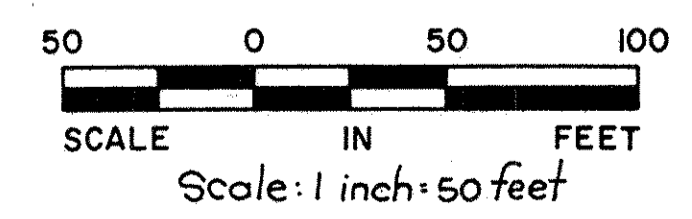
PARKWAY TERRACE 2ND ADDITION
