

I hereby certify that in accordance with the provision of Chapter 508, Minnesota Statutes of 1949 as amended, I have surveyed the following described tracts of land in the County of Ramsey and State of Minnesota to wit: (That part of the East Half of the Southeast Quarter of Section 22, Township 30 North, Range 22 West, according to the U.S. Government Survey thereof as of record and file in the Office of the Register of Deed in and for Ramsey County, Minnesota, described as: Commencing at a point on the West Line of said Fast Half, 580.73 feet North of the Southwest Corner of said East Half: thence East 236.41 feet to the Easterly line of Otter Lake Road, the Point of Beginning: / thence N. 180 02 W. along the said Easterly Line 559.47 feet to the Southerly Line of Goose Lake Road (now vacated): thence N. 570 05: E. along said Southerly Line 413:00 feet to the Westerly R-O-W. Line of the N. P. Ry. Cos thence on Curve to the Right (Radius 453.34 feet, Chord 200.02 feet) along said R-O-W.
