

I hereby certify that in accordance with the provisions of Chapter 508, Minnesota Statutes of 1949 amended, I have surveyed the following described tract of land in the county of Ramsey, Minnesota to wit: That part of Section 9, Township 29, Range 22, Ramsey County, Minnesota, Described as follows: Beginning at a point on the west line of said Section 9,464.97 feet North of the Southwest corner of said Section 9; thence East and parallel with the South line of said Section 9, a distance of 525.60 feet to a point; "thence North and parallel with the said West lineof Section 9, a distance of 101.90 feet to a point; thence East and parallel with the said South line of Section 9,194.76 feet to the Westerly line of Keller Parkway; thence Northerly along the Westerly line of Keller Parkway, 52.27 feet to a point; thence West and parallel with the South line of said Section 9, a distance of 241.47 feet to the intersection with a line 456.67 feet East of and parallel with the said West line of Section 9; thence North and parallel with the West line of said Section 9, a distance of 100 feet to a point; thence East and parallel with the South line of said Section 9, 194.14 feet to the Westerly line of Keller Parkway; thence Northerly along the Westerly line of said Keller Parkway 150.05 feet to its intersection with a line 850 feet North of and parallel with said South line of said Section 9; thence West and parallel with the South line of said Section 9, 403.50 feet to a point 183 feet East of the West line of said Section 9; thence South and parallel with the West line of said Section 9, 150 feet to a point; thence West and parallel with the South line of said Section 9, 183.0 feet to the West line of said Section 9; thence South along the said West line of Section 9, 235.03 feet to the point of beginning, subject to whatever rights the public may have over Arcade Street and including in the above or preceding description whatever rights the parties may have in so-called Keller Parkway, excepting from the above the following;
