I hereby certify that in accordance with the provision of Chapter 508, Minnesota Statutes of 1949 as amended, I have surveyed the following described tract of land in the County of Ramsey and State of Minnesota, to-wit:

Tract "H". Registered Land Survey No. 124, except the North one hundred ten (110) feet of East one hundred fifty (150) feet of Tract "H" (measured from the straight parts of the North and East lines of said Tract "H" and extensions thereof); also except that part described as follows: Beginning at a point on the East line of said Tract "H" distant 441 feet South of an Easterly extension of the straight part of the Northerly line of said Tract "H"; thence South on said East line (bearing South), 150 feet; thence West, 130.8 feet; thence N. 4° 04° W., 45 feet; thence N. 43° 17° 10" E., 144.39 feet; thence East, 35 feet to the point of beginning; also except the South one hundred eight (108) feet of the North three hundred twenty-one (N.321) feet of East one hundred fifty (E.150) feet of Tract "H", Registered Land Survey No. 124, said three hundred twenty-one (321) feet being measured from the straight portion of the North line of said Tract "H" and Easterly extension thereof, and also except that part of Tract "H", Registered Land Survey No. 124 described as follows: Beginning at a point on the West line of said Tract "H" distant 321 feet South of a Westerly extension of the North line of said tract; thence bearing East and at right angles to said West line, 193 feet to a point distant 150 feet West of the East line of said tract; thence South 40 04 East, 170 feet; thence North 59° 56' 30" West, 198.79 feet; thence West 33 feet to said West line; thence North on said West line 70 feet to the point of beginning, subject to Bald Eagle Boulevard West, on file in the office of the Registrar of Titles within and for said county. That the survey shown herein is a true and correct delineation of said survey.
