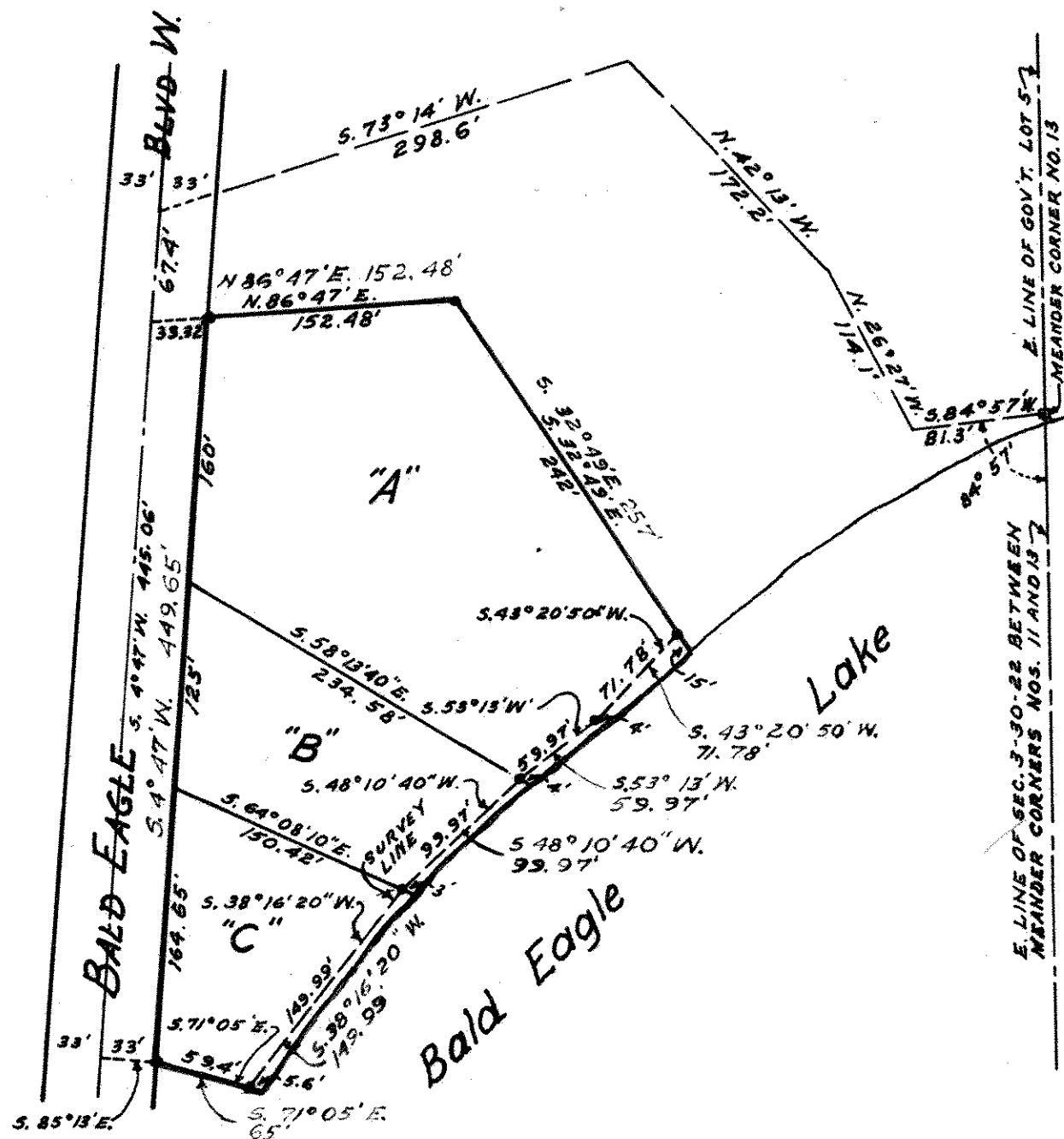

I hereby certify that in accordance with the provision of Chapter 508, Minnesota Statutes of 1949 as amended, I have surveyed the following described tract of land in the County of Ramsey and State of Minnesota, to-wit:

That part of Government Lot 5, Section 3, Township 30, Range 22 lying Easterly of Bald Eagle Boulevard West and lying Southerly and Westerly of lines described as follows: Commencing at meander corner No. 13 on the East line of said Section 3; thence S. 84° 57' W. (at an angle of 84° 57' to the East line of said Section 3 between meander corners Nos. 11 and 13) for 81.3 feet; thence N. 26° 27' W. 114.1 feet; thence N. 42° 13' W. 172.2 feet; thence S. 73° 14' W. 298.6 feet to the center line of Bald Eagle Boulevard West; thence S. 4° 47' W. on said center line 67.4 feet to the point of beginning of the lines to be described; thence N. 86° 47' E. 185.8 feet; thence S. 32° 49' E. 257 feet to the shore of Bald Eagle Lake; And lying Easterly and Northerly of lines described as follows: Beginning at the afore described point of beginning; thence S. 4° 47' W. on said center line of Bald Eagle Boulevard West 445.06 feet; thence S. 85° 13' E. 33 feet to the Easterly line of said Bald Eagle Boulevard West; thence S. 71° 05' E. 65 feet to the shore of Bald Eagle Lake; And lying Northwesterly of Bald Eagle Lake. Except that part thereof taken for Bald Eagle Boulevard West.
