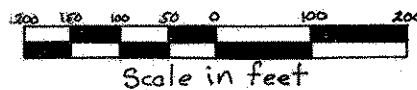


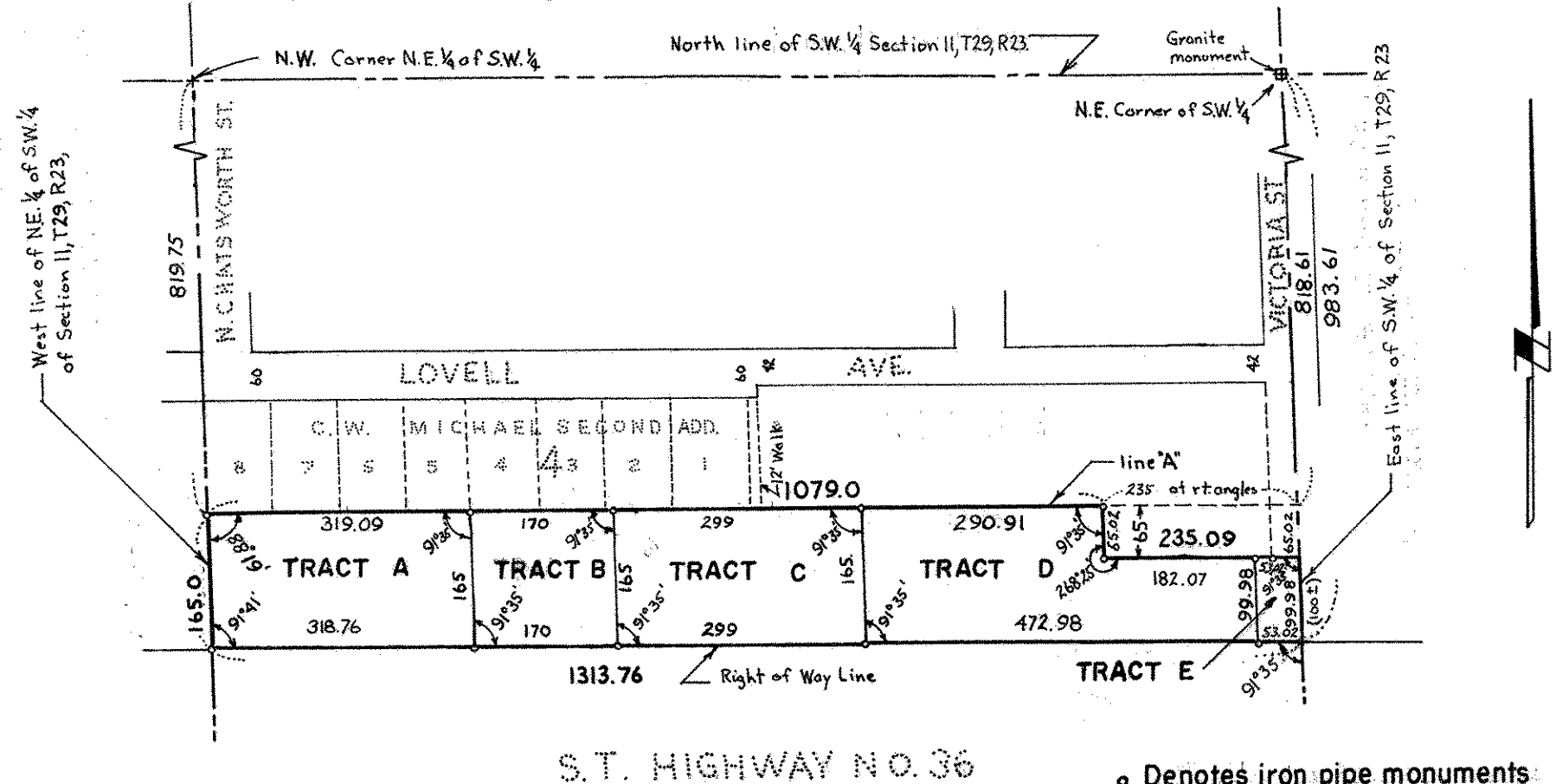
# REGISTERED LAND SURVEY NO. 301

## Description:

That part of the Northeast Quarter of the Southwest Quarter of Section 11, Township 29, Range 23, described as beginning at a point on the West line of said Northeast Quarter of the Southwest Quarter distant 819.75 feet South from the Northwest Corner of said Northeast Quarter of the Southwest Quarter; thence South along said West line 165 feet; thence East to a point on the East line of said Southwest Quarter distant 983.61 feet South from the Northeast corner of said Southwest Quarter; thence North along said East line 100 feet, more or less, to an intersection with a line drawn parallel to and 65 feet South, measured at right angles, from a line hereinafter referred to as line "A", said Line "A" extending from the point of beginning to a point on the East line of said Southwest Quarter, distant 818.61 feet South from the Northeast corner of said Southwest Quarter; thence West along said last described parallel line to an intersection with a line drawn parallel to and 235 feet West, measured at right angles, from said east line of the Southwest Quarter; thence North along said last described parallel line to an intersection with said line "A", thence West along said Line "A" to the point of beginning; according to the United States Government Survey thereof.
