The North two hundred twenty-seven and fifty-one hundredths (N 227.51) feet of the following described tract: All of the West one-half (W 1/2) of the Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4) of Section eleven (11), Township twenty-nine (29) North, Range twenty-three (23) West, except the East four hundred thirty-five (E. 435) feet thereof and except that part described as follows: Beginning at the point of intersection of the South line of County Road "C" as now located and the West line of said West one-half (W 1/2) of the Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4) of said Section eleven (11); thence South on the West line of said West one-half (W. 1/2) of said Northeast quarter (NE 1/4) of the Northeast quarter (NE 1/4) of said Section, two hundred twenty-seven and fifty-one hundredths (227.51) feet; thence East and parallel to the North line of said quarter (1/4) section, one hundred four and fifty-four hundredths (104.54) feet; thence North two hundred twenty-eight and seventy-three hundredths (N. 228.73) feet to a point on the South line of County Road "C" as now located one hundred four and eighty-three hundredths (104.83) feet East of the place of beginning; thence West on the South line of County Road "C", one hundred four and eighty-three hundredths (104.83) feet to the place of beginning, according to the United States Government Survey thereof.
