A parcel of land described as follows: Commencing at a point in the easterly line of the White Bear Road, also known as Highway No. 1, 383.8 feet north of the south line of Section four (4), Township twenty-nine (29), Range twentytwo (22); thence east on a line parallel to and 383.8 feet distant from said south line of said Section four (4) to a point in the west line of Lot six (6) of Kohlman's Lakeview Addition, Ramsey County, Minnesota, according to the plat thereof on file and of record in the office of the Register of Deeds within and for said Ramsey County; thence north along the said west line of said Lot six (6) to the point of beginning, said point being 120.55 feet south of the northwest corner of said Lot six (6); thence west on a line parallel to the south line of Section four (4), Township twenty-nine (29) N., Range twenty-two (22) W., to a point in the easterly line of the White Bear Road, known as Highway Number One; thence southwesterly along the southeasterly side of said White Bear Road to a point three hundred eighty-three and eight-tenths (383.8) feet north of the south line of said Section four (4); thence east on a line three hundred eighty-three and eight-tenths (383.8) feet north of and parallel to the south line of said Section four (4) to a point on the west line of said Lot six (6); thence north along the west line of said Lot six (6) to the point of beginning, according to the survey thereof, except that part described as follows: Commencing at a point on the west line of Lot six (6) of Kohlman's Lakeview Addition, Ramsey County, Minnesota, according to the recorded plat thereof on file and of record in the office of the Register of Deeds in and for Ramsey County, Minnesota, and two hundred (200) feet south of the northwest corner of said Lot six (6); thence west on a line parallel to the south line of Section four (4), Township twenty-nine (29) N., Range twenty-two (22) W., to a point on the easterly line of the White Bear Road, known as Highway Number One; thence southwesterly along the southeasterly side of said White Bear Road to a point three hundred eighty-three and eight-tenths (383.8) feet north of the south line of said Section four (4); thence east on a line three hundred eighty-three and eight-tenths (383.8) feet north of and parallel to the south line of said Section four (4) to a point on the west line of said Lot six (6); thence north along the west line of said Lot six (6) to the point of beginning.
