
## REGISTERED LAND SURVEY NO. 499

Lot 3, Block 1, Eastern Area Addition except that part overlying the following described property: That part of Lot 18, Block 22 lying between the extended West line of Lot 4 in said Block 22 and the extended center line of Lot 4, Ashton and Sherburne's Addition to Saint Paul; Lots 26 to 32 inclusive, and Lot 34, Block 16 except that portion of Lot 34 lying southerly of a line drawn from a point on the Easterly boundary line of Lots 34 and 13, said point being equal distance from Valley Street and Mt.Airy Street; thence Westerly to a point on the Westerly boundary of said Lot 34, said point being equal distance from Valley Street and Mt.Airy Street, in Dewey, Bass & Rohrer's Addition to the City of Saint Paul; also except that part lying southwesterly of the following described line and its extension northwesterly: Commencing at the southwesterly corner of said Lot 3; thence North 56 degrees East (assumed bearing) along the southeasterly

line of said Lot 3 a distance of 400 feet to the point of beginning of the line to be described; thence North 34 degrees West to the intersection with the northwesterly line of said Lot 3 which was formerly the northwesterly line of Lot 9, Block 22, Ashton and Sherburne's Addition to Saint Paul and there terminating.
