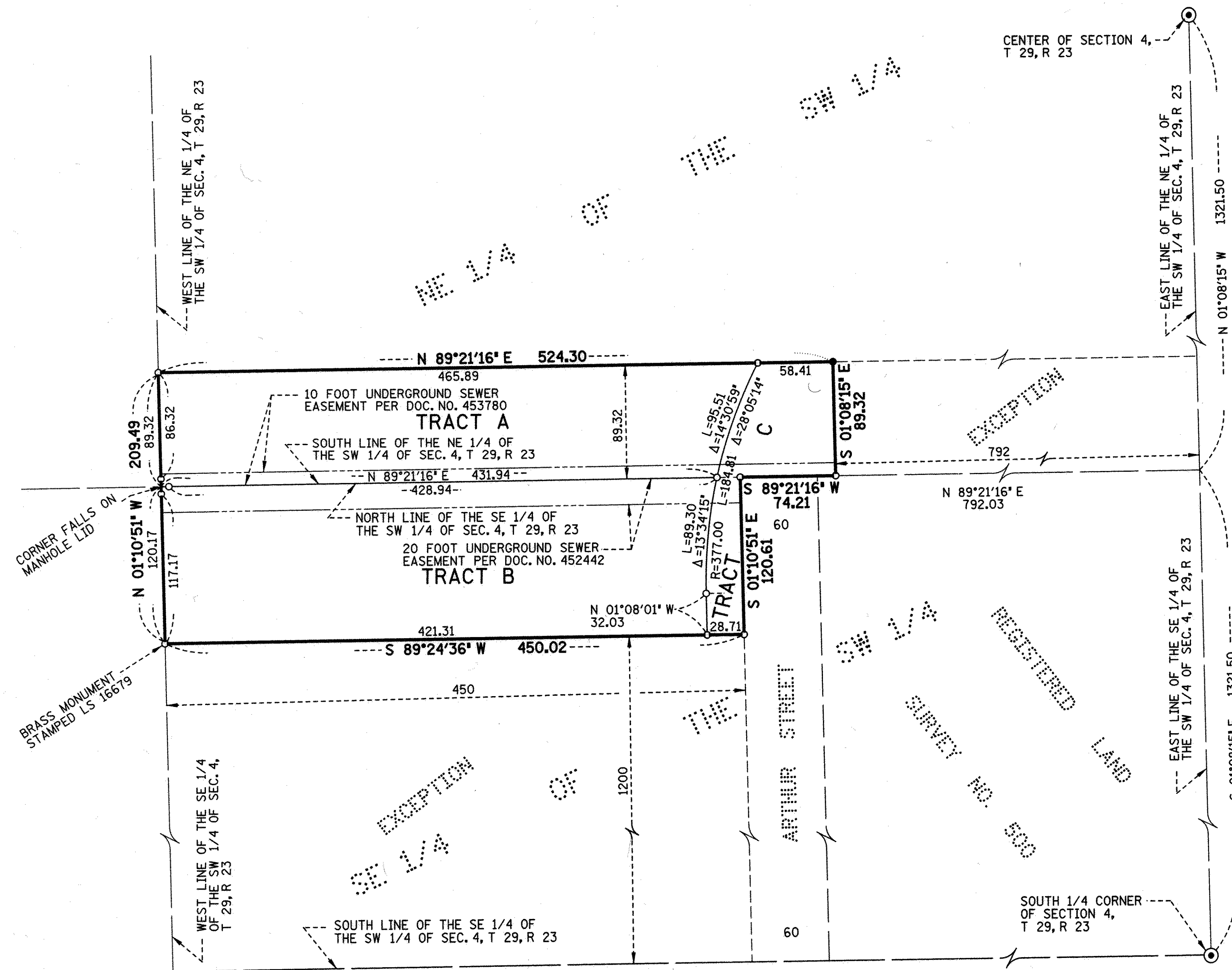
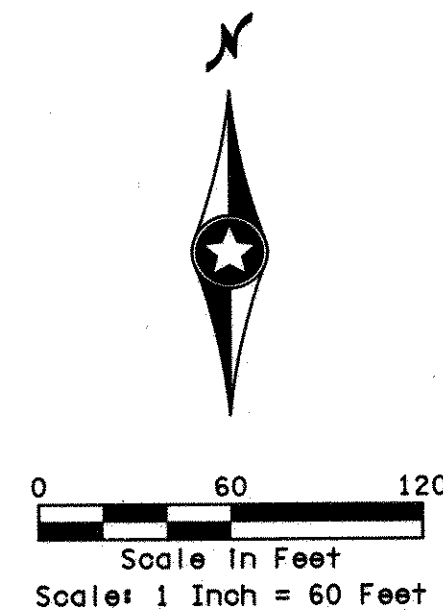


REGISTERED LAND SURVEY NO. 625
