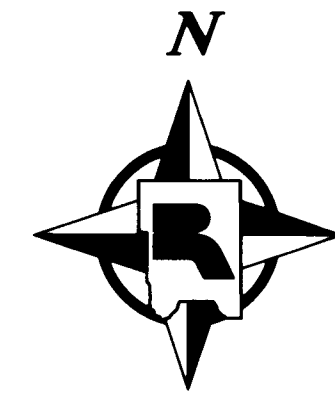

NOTES

Parcel boundaries and corresponding parcel acreage shown hereon have been determined from Ramsey County and the City of Saint Paul survey records, descriptions, subdivision plat computations and field verification of existing survey monuments.

The listing of recorded owners in the parcel table was created from Certificates of Title and other documents of record provided in the form of a "Property Report" by Land Title Inc. with a "Posted Effective Date" of November 27, 2012.

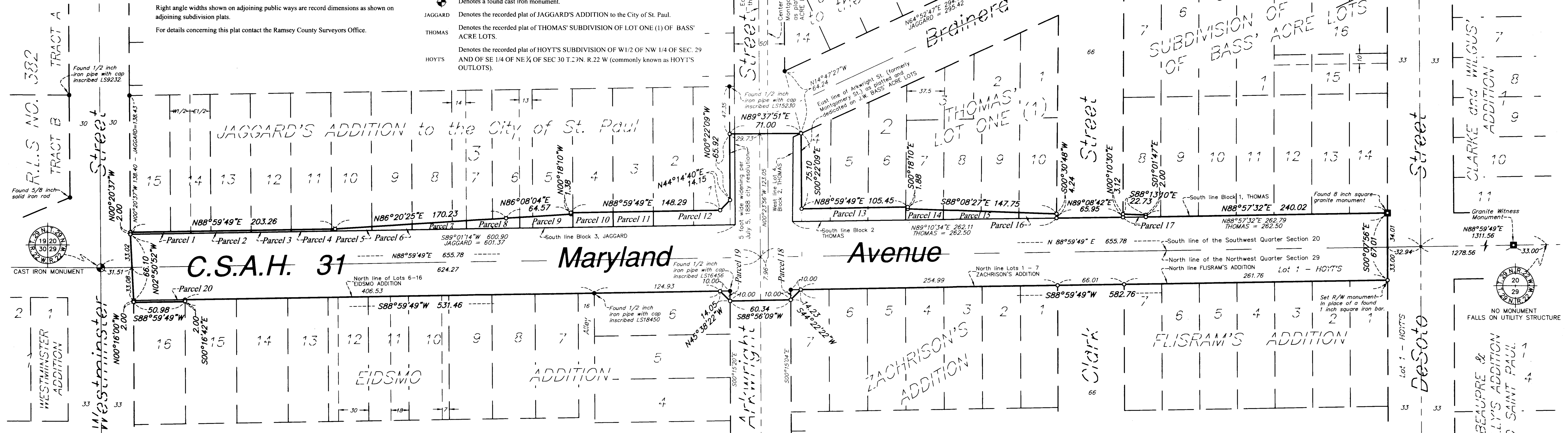
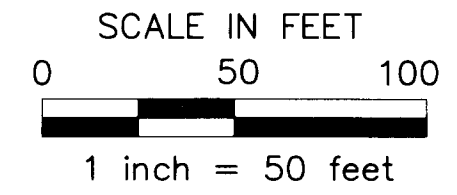
The bearings shown on this plat are based on the Ramsey County Coordinate System NAD83 (1996), together with information shown on the City of Saint Paul section worksheets.

Right angle widths shown on adjoining public ways are record dimensions as shown on adjoining subdivision plats.

LEGEND

- Denotes a right of way boundary monument consisting of a 5/8 inch by 14 inch solid iron rod with an aluminum cap inscribed "Ramsey County R/W - LS 20261". If physical conditions following construction prohibit setting an iron rod a survey nail with disk inscribed "RAMSEY COUNTY - LS 20261" will be substituted.
- Denotes found 1/2 inch iron pipe monument with no cap unless otherwise noted. If found monument is destroyed during construction it will be replaced with a 1 inch by 14 inch solid iron rod with a plastic cap inscribed "RAMSEY COUNTY - LS 20261". If physical conditions following construction prohibit setting an iron rod a survey nail with disk inscribed "RAMSEY COUNTY - LS 20261" will be substituted.
- ⊕ Denotes a found cast iron monument.
- JAGGARD Denotes the recorded plat of JAGGARD'S ADDITION to the City of St. Paul.
- THOMAS Denotes the recorded plat of THOMAS' SUBDIVISION OF LOT ONE (1) OF BASS' ACRE LOTS.
- HOYT'S Denotes the recorded plat of HOYT'S SUBDIVISION OF W 1/2 OF NW 1/4 OF SEC. 29 AND OF SE 1/4 OF NE 1/4 OF SEC 30 T.29N. R.22 W (commonly known as HOYT'S OUTLOTS).
