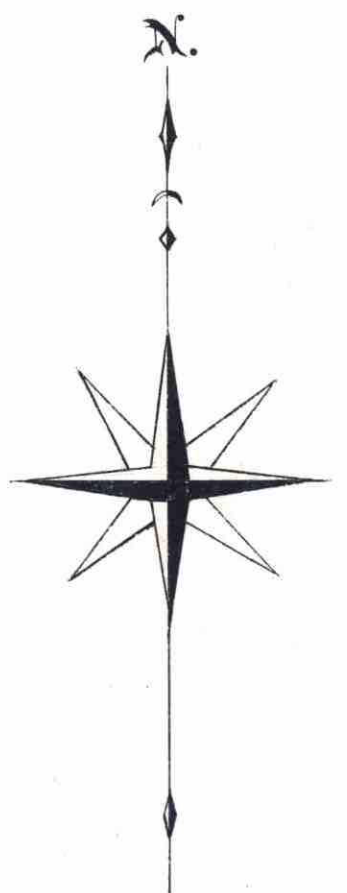


MAP
