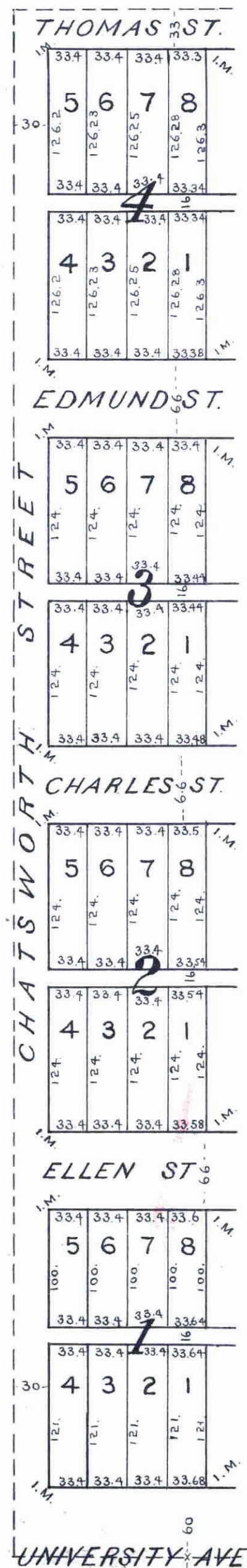


WEED AND LAWRENCE'S ADDITION TO SAINT PAUL MINN.
