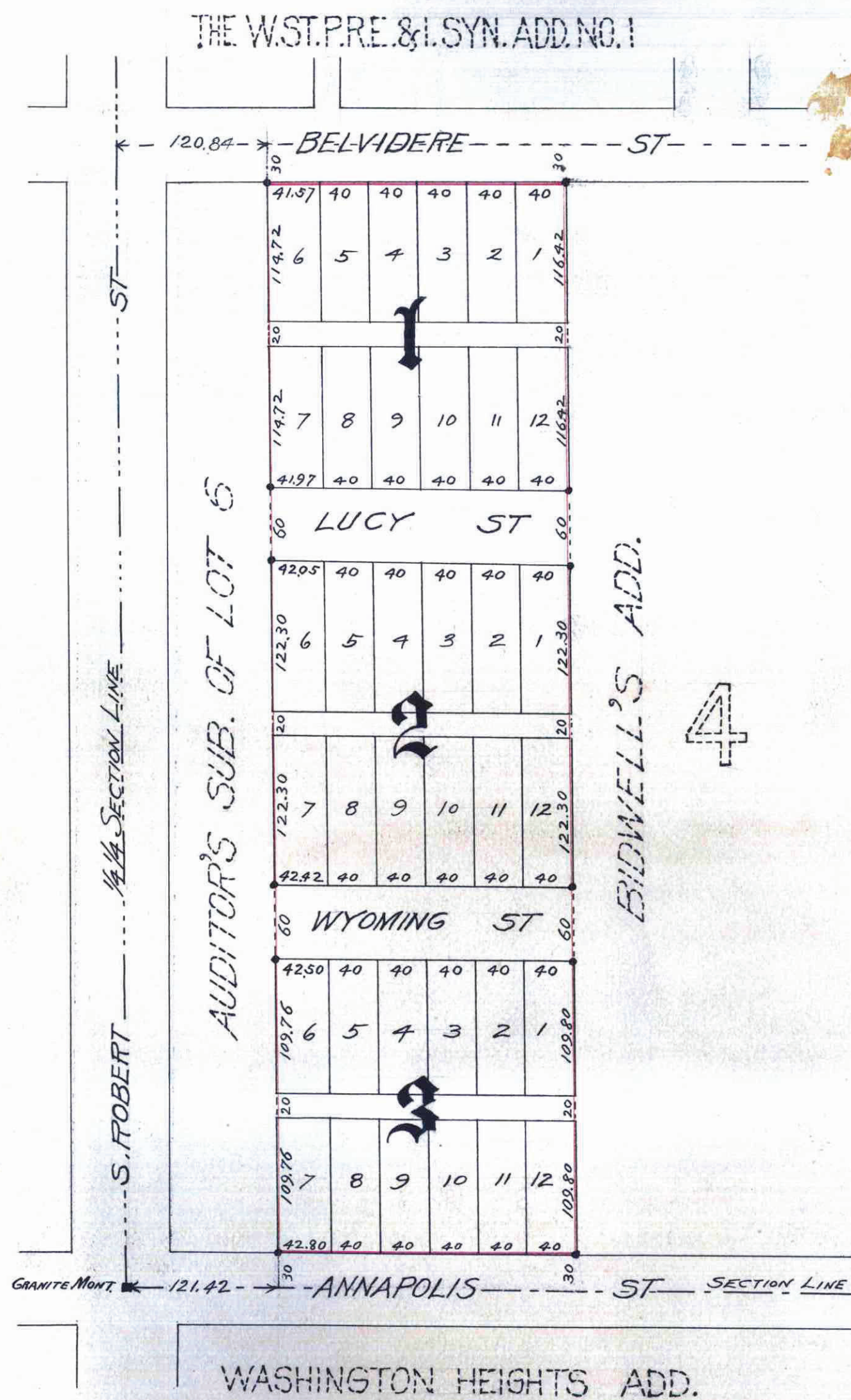


SAUER'S ADDITION TO ST. PAUL
