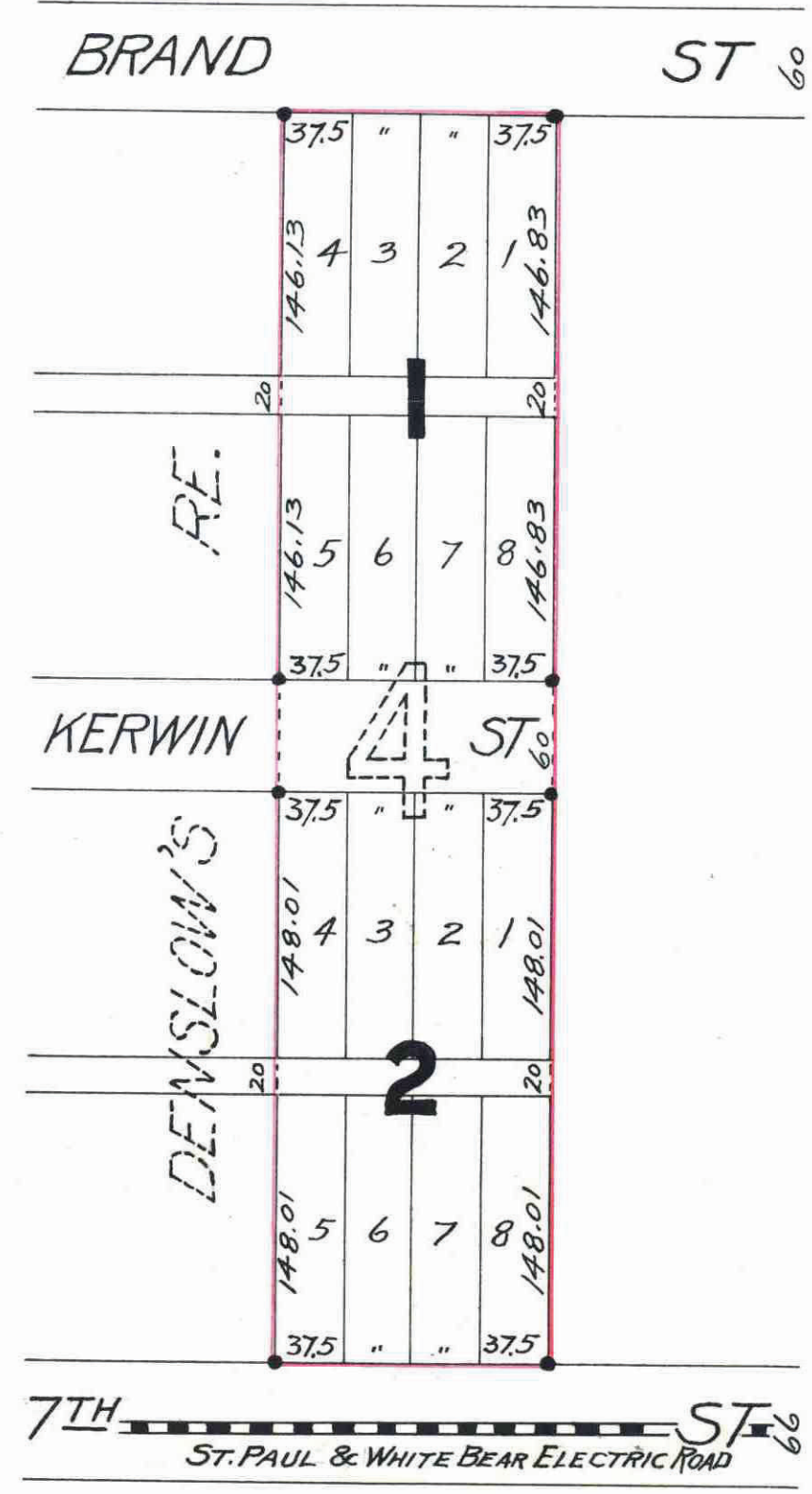


# Cedar Park ST. PAUL.
