



This is to certify that, Sharon Land Company, a corporation existing under and pursuant to the laws of the State of Minnesota, proprietor of the following described tract, - commencing at the point where the east line of Hester Street intersects the north line of McLean Avenue in the City of St. Paul in said Ramsey County, thence east two hundred seventy and 63/100 (270 63/100) feet more or less, to the east line of King's Addition, thence north along the west line of King's Addition one hundred thirty seven and 98/100 (137 98/100) feet, more or less to the south line of F. Knauft's Pacific Street Addition, being the south line of the ten (10) feet wide strip on the south side of said F.
