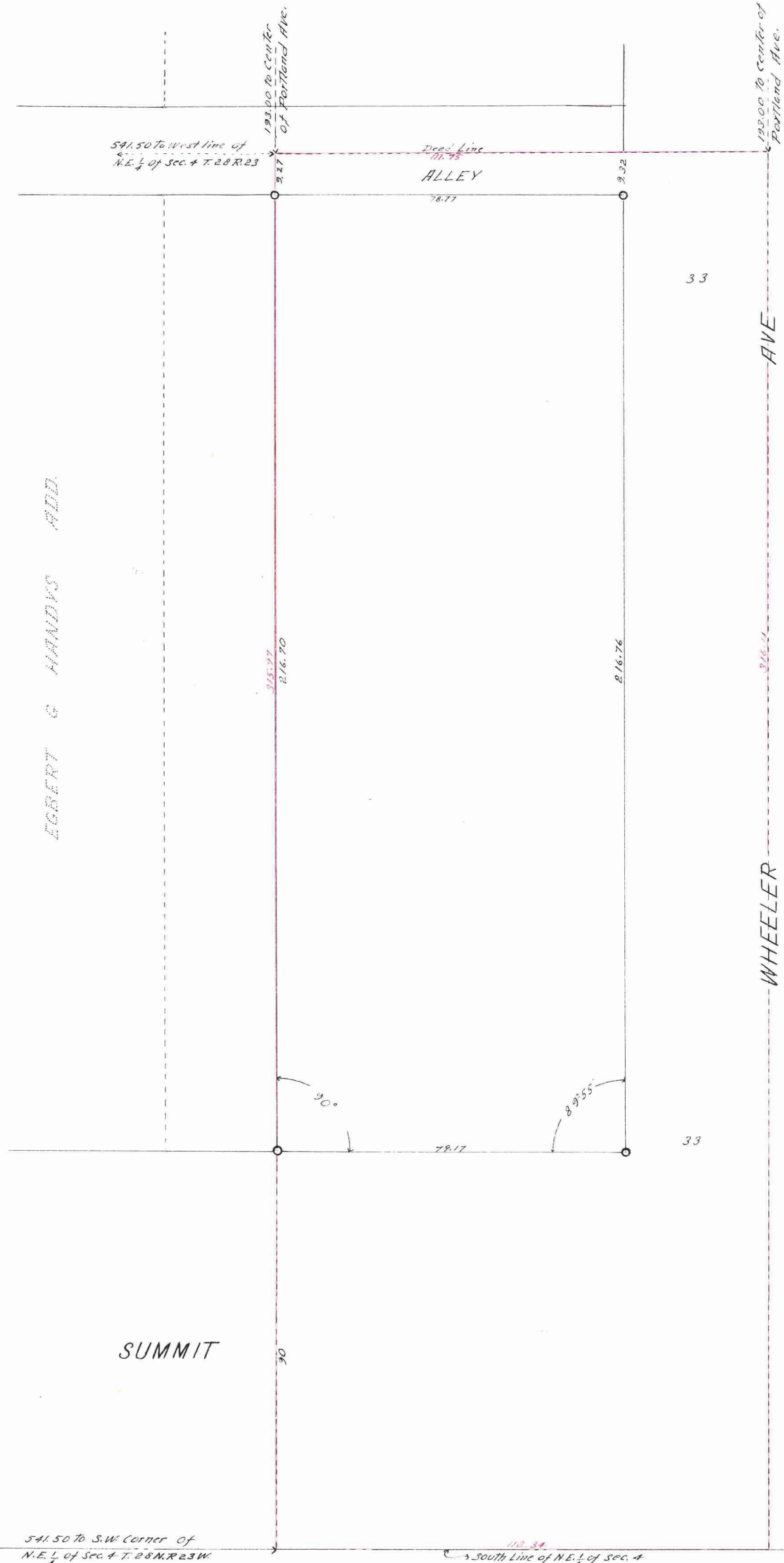


WHITACRE PLACE
