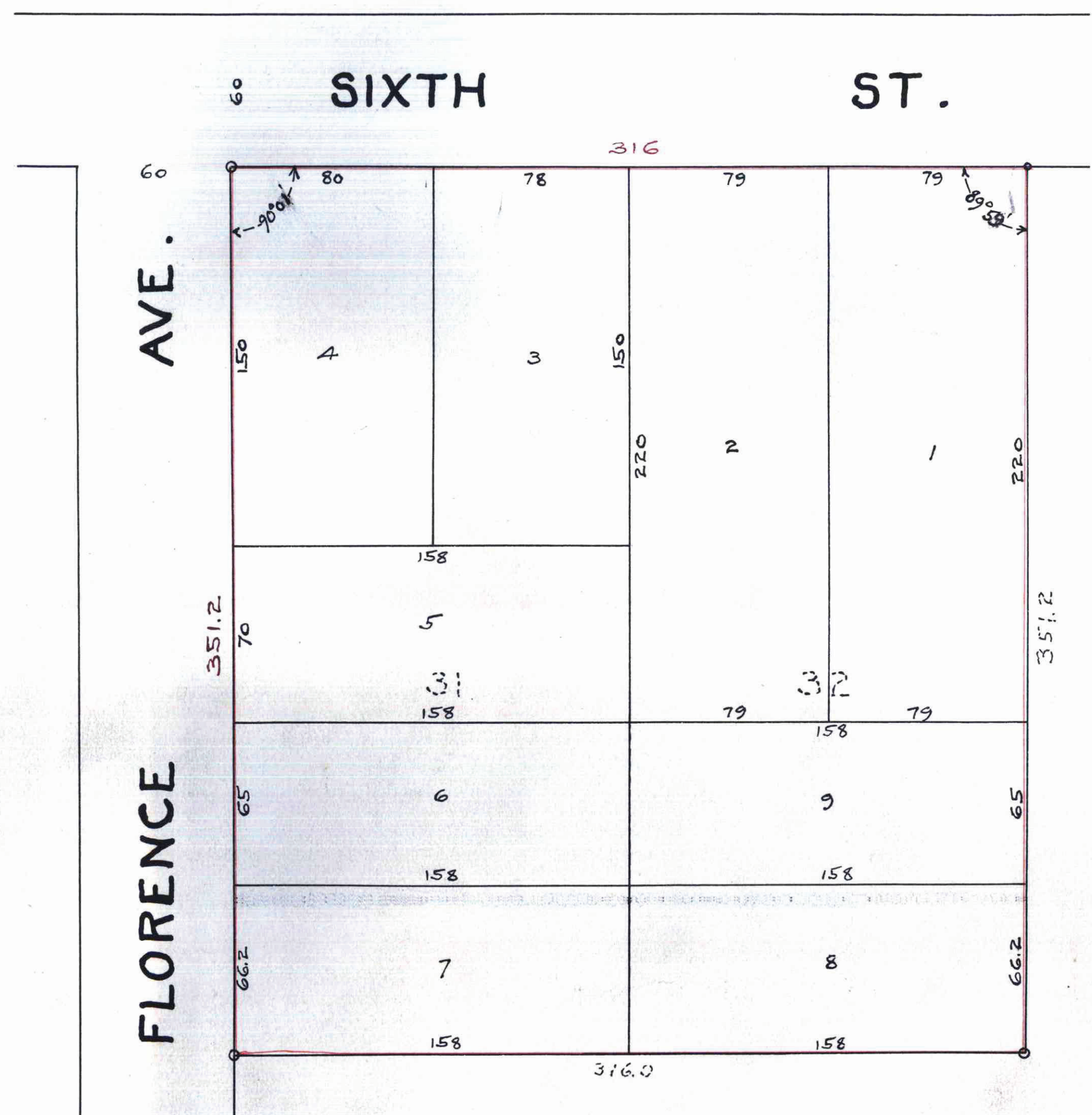


# BELLEAU-WOOD WHITE BEAR LAKE MINN
