

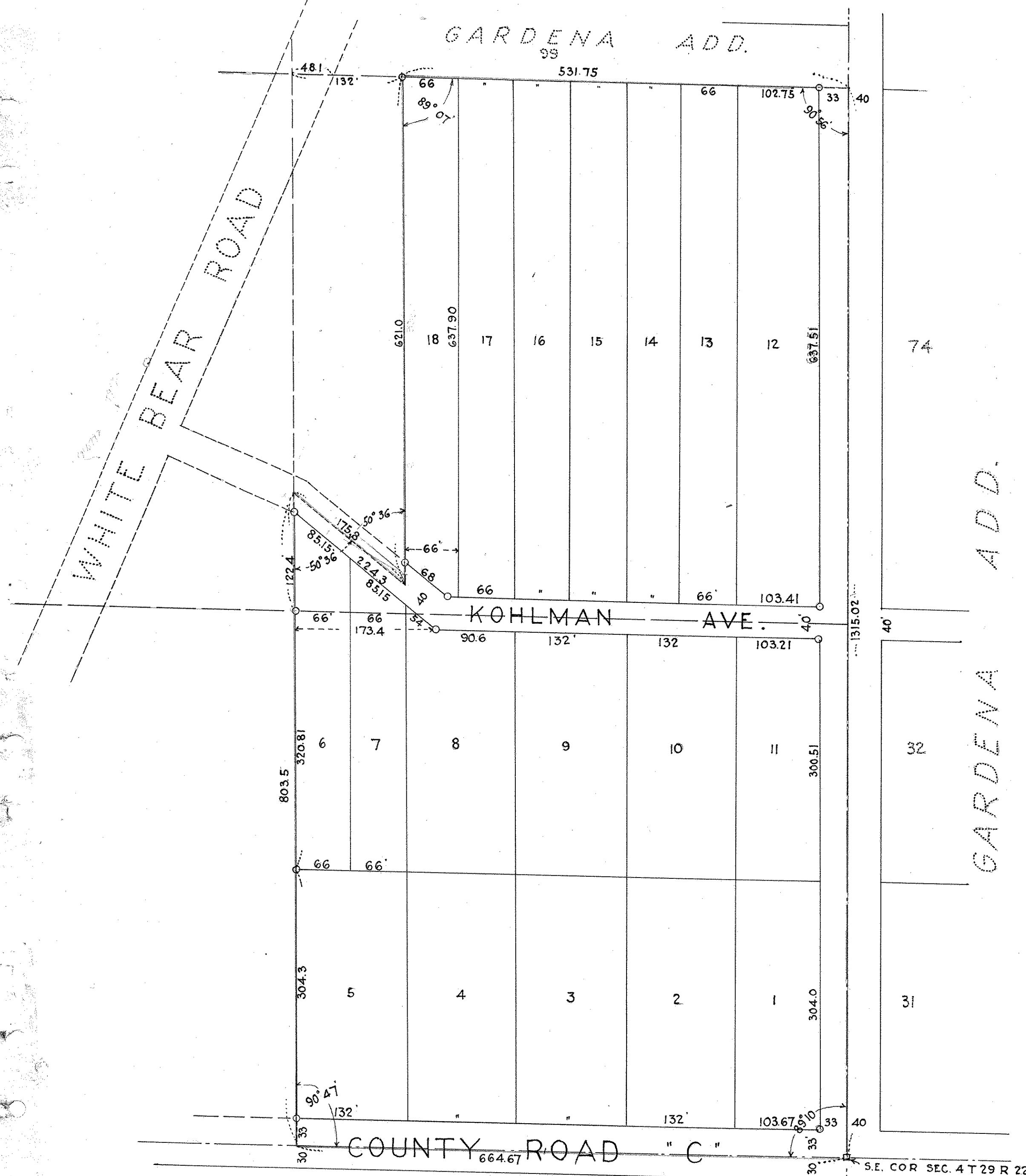
KOHLMAN'S LAKEVIEW ADD.
