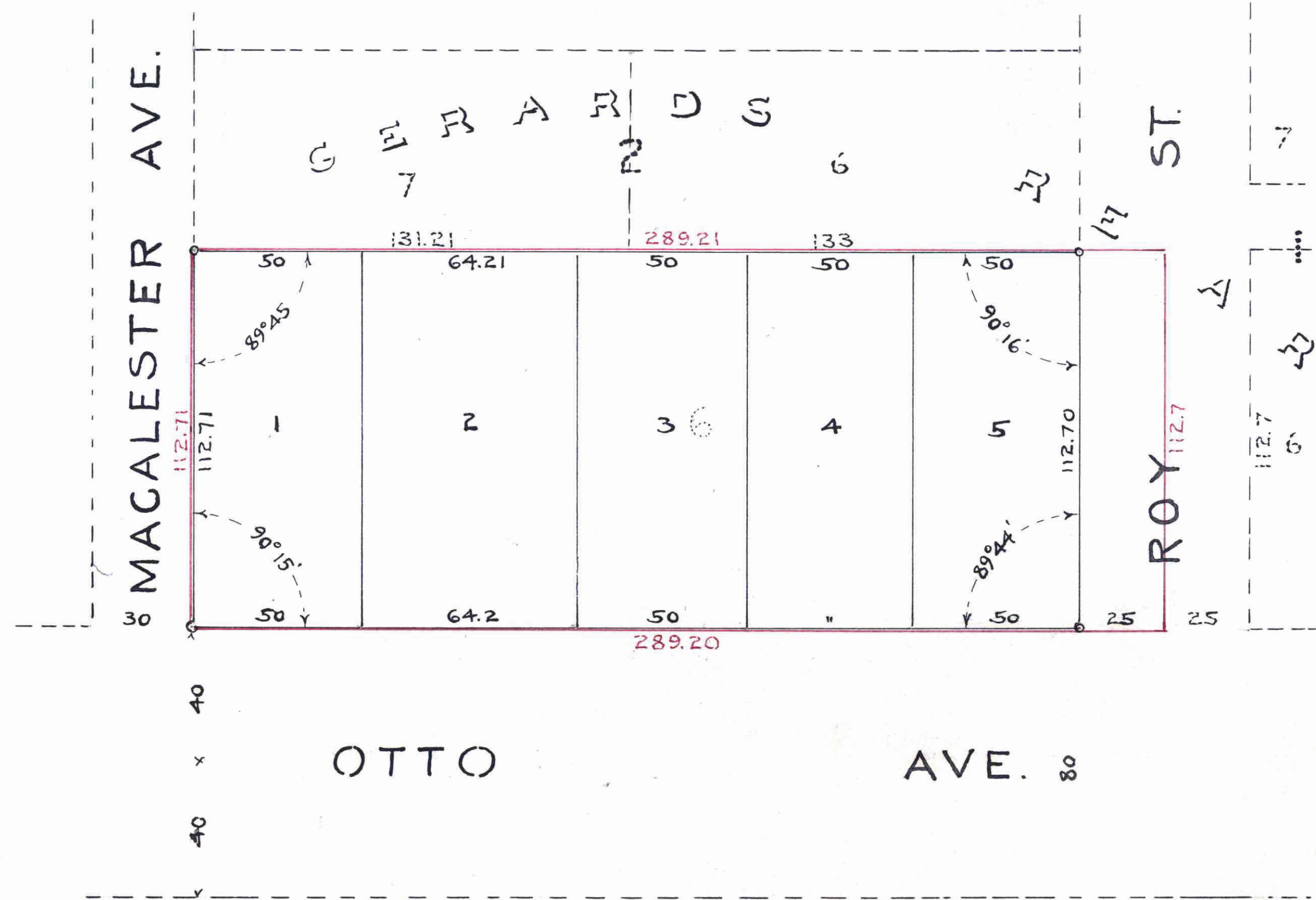


WITHEE ADDITION
