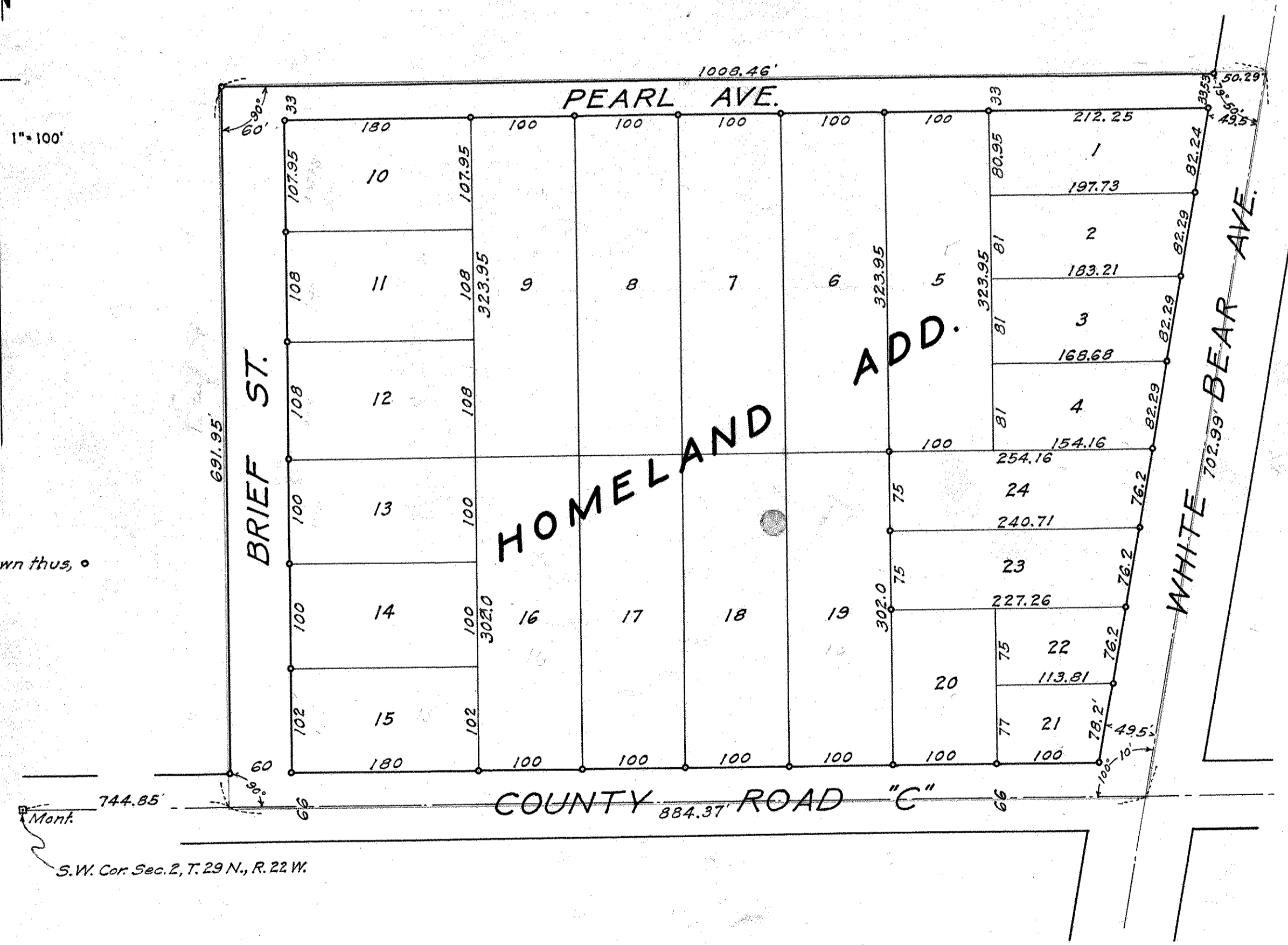
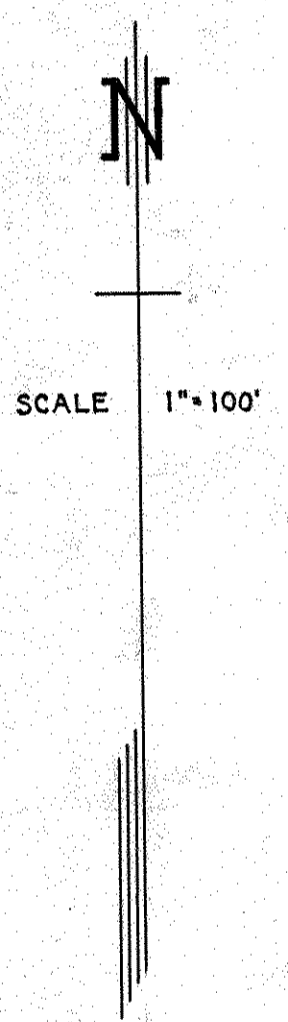


**HOMELAND ADDITION**
