C. F. No. 118995—By F. M. Traas—Whereas, Clyde L. and Jennie Malmquist are the owners of a tract of land slightly over 80 feet in width, which tract is adjacent to Block 3 of J. A. and W. M. Stees Addition, and is bounded on the west by Mendota Street, on the north by Hyacinth Street, and on the south by Orange Street; and Whereas, All of the other property immediately adjacent to the tract of land has heretofore been platted into forty-foot lots which do not have the required area as provided under Article 1, Section 2, Subdivision (b) of Ordinance No. 546, as amended (known as the Zoning Ordinance); and Whereas, The said Clyde L. and Jennie Malmquist have appealed to the Council under the provisions of Article 4, Section 20, Subdivision (1) of said Zoning Ordinance, for permission to plat said described tract of land into four lots of a width of 40 feet or more and a depth of 121 feet; and Whereas, The Board of Zoning recommends the allowance of said appeal; therefore, be it Resolved, That said appeal is hereby granted, and the said Clyde L. and Jennie Malmquist are hereby authorized and permitted to plat the above described land into four lots as aforesaid.
