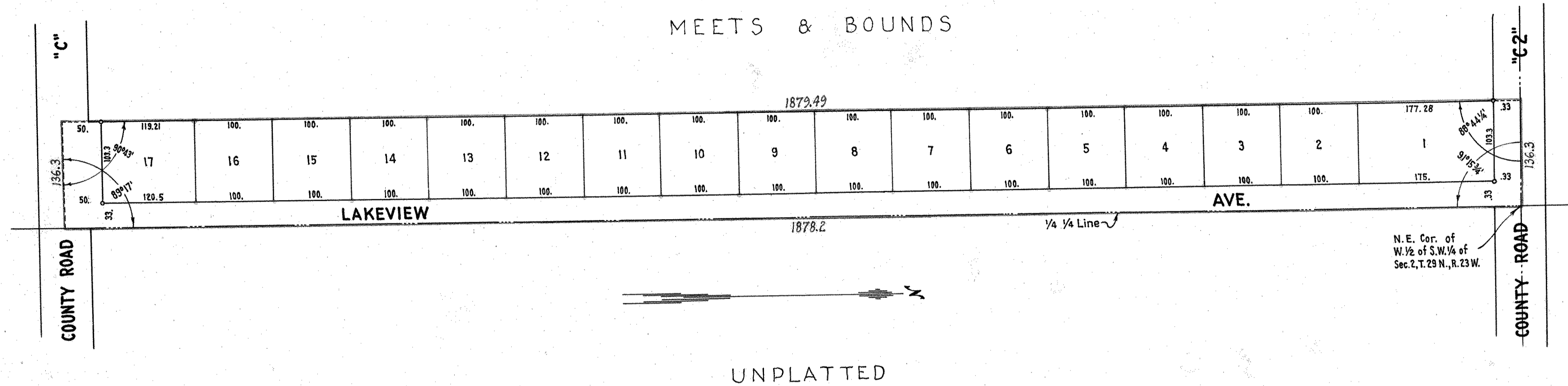


REILING PARK RAMSEY CO., MINN.
