


SUMMIT FARM HOMESITES

This is to certify that we, Robert M. Hansen and Clara E. Hansen, husband and wife, owners of:-- all that part of the Southeast quarter (S.E. 1/4) of Section twenty-seven (27), Township thirty (30) North, Range twenty-two (22) West lying East of the East line of Scheuneman Road and West of the West line of Northern Pacific Ry. Co's right of way, except the South two hundred seventy (270) feet thereof and except that part thereof lying North of a line running from a point on said East line of road distant three hundred sixty-four and seven tenths (364.7) feet Southwesterly from the North line of said Southeast quarter (measured on said road line) to a point on said West line of right of way distant three hundred sixty-eight and twenty-five hundredths (368.25) feet Southwesterly from said North line (measured on said West line); also all that part of the North one thousand one hundred fifty-six and twenty-three hundredths (1156.23) feet of said Southeast quarter lying West of the West line of said road and lying East of a line running Southwesterly at an angle of 82°19' to aforesaid North line from a point thereon distant five hundred forty-six and seventy-five hundredths (546.75) feet East of the Northwest corner of said Southeast quarter for a distance of seven hundred twenty-eight and forty-one hundredths (728.41) feet; thence at an angle of 6°07' to the left, four hundred thirty-four and fifty-two hundredths (434.52) feet; have caused the same to be surveyed and platted and hereafter known as Summit Farm Homesites, as shown by this plat, and hereby dedicate to the public and for the public use forever all roads and streets as shown.
