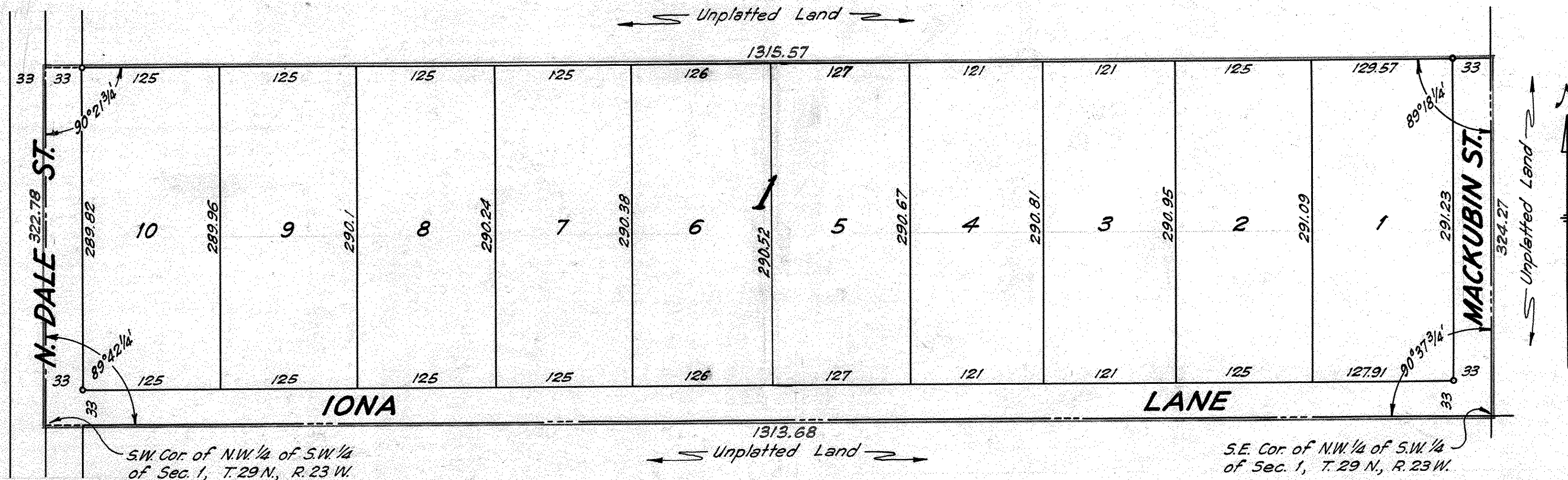


# NORTH DALE PARK ROSEVILLE, MINN.
