


EDGETOWN ACRES

This is to certify that we, Suburban Properties Inc, owners of: South half (S 1/2) of the North half (N 1/2) of the Southeast quarter (S.E. 1/4) and also the West ten (10) acres of the Southeast quarter (S.E. 1/4) of the Southeast quarter (S.E. 1/4) and also except the West eighth (W 1/8), the Southwest quarter (S.W. 1/4) of the Southeast quarter (S.E. 1/4) all in Section four (4) Town thirty (30) North, Range twenty three (23) West. Also described as follows: Beginning at a point on the south line of Section four (4), Township thirty North (T 30N), Range twenty-three West (R 23W), at a distance of one hundred sixty-four and sixty-three hundredths feet (164.63') east of the south one-quarter (1/4) corner; thence East on the south line thereof a distance of one thousand four hundred eighty-one and sixty-eight hundredths feet (1481.68'); thence deflect to the left at an angle of ninety degrees, forty-six minutes (90°46'), a distance of one thousand three hundred sixteen and nineteen hundredths feet (1316.19'); thence deflect to the right at an angle of ninety degrees, fifty minutes (90°50'), a distance of nine hundred eighty-six and twenty-five hundredths feet (986.25'); thence deflect to the left at an angle of ninety degrees, fifty-four minutes (90°54'), a distance of six hundred fifty-seven and forty-six hundredths feet (657.46'); thence deflect to the left at an angle of eighty-nine degrees, three minutes (89°03'), a distance of two thousand six hundred twenty-seven and ninety-five hundredths feet (2627.95'); thence deflect to the left at angle of ninety degrees, forty-six minutes (90°46'), a distance of six hundred fifty-nine and fifteen hundredths feet (659.15'); thence deflect to the left at an angle of eighty-nine degrees, seventeen minutes (89°17'), a distance of one hundred sixty-four and thirty-seven hundredths feet (164.37'); thence deflect to the right at an angle of eighty-nine degrees, sixteen minutes (89°16'), a distance of one thousand three hundred eighteen and one tenth feet (1318.1') to the point of beginning; subject to Shuffa Road, County Road 1 and the St. Paul City Waterworks easements, have caused the same to be surveyed and platted and hereafter known as Edgetown Acres as shown by this plat and we hereby dedicate to the public and for the public use forever all streets, avenues and easements as shown.
