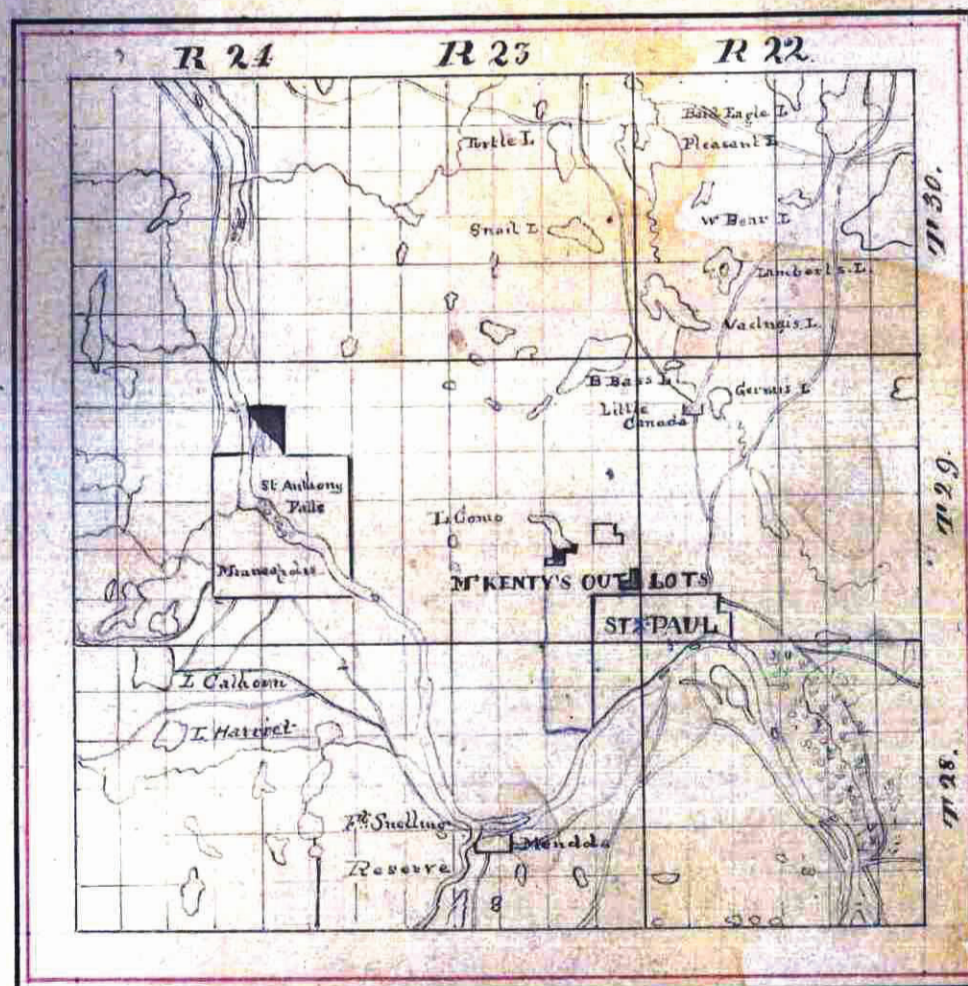

Where all men by these presents that I Henry McKenty of Saint Paul in the County of Ramsey and Territory of Minnesota did on the 25th day of November A.D. 1856, duly authorize Wellman & Johnson Surveyors who sign the within Plat to Survey and plat "McKenty's out lots to Saint Paul" in the County of Ramsey in said Territory. And I do hereby release all my right, title, interest and claim in and to the Streets as laid out in the within plat, and give the same for Public use.

I do hereby certify that this is a correct Plat of "McKenty's out lots to Saint Paul" being in Section Twenty Five (25) Township Twenty Nine (29) Range Twenty Three (23), west containing seven one half acres and described as follows: Beginning at the South East corner of N.E. 1/4 quarter of 1/4 quarter (1/4) of Section Twenty five thence North along the Section Line fifty three and one third (53 1/3) rods, thence West at right angles with said line of fifteen (15) rods, thence South twenty five and two thirds (25 2/3) rods, thence West at right angles fifteen (15) rods, thence South twenty five and two thirds (25 2/3) rods, thence East at right angles thirty (30) rods to the place of beginning all streets 25 feet, and all lots 98 1/2 ft by 26 feet.
