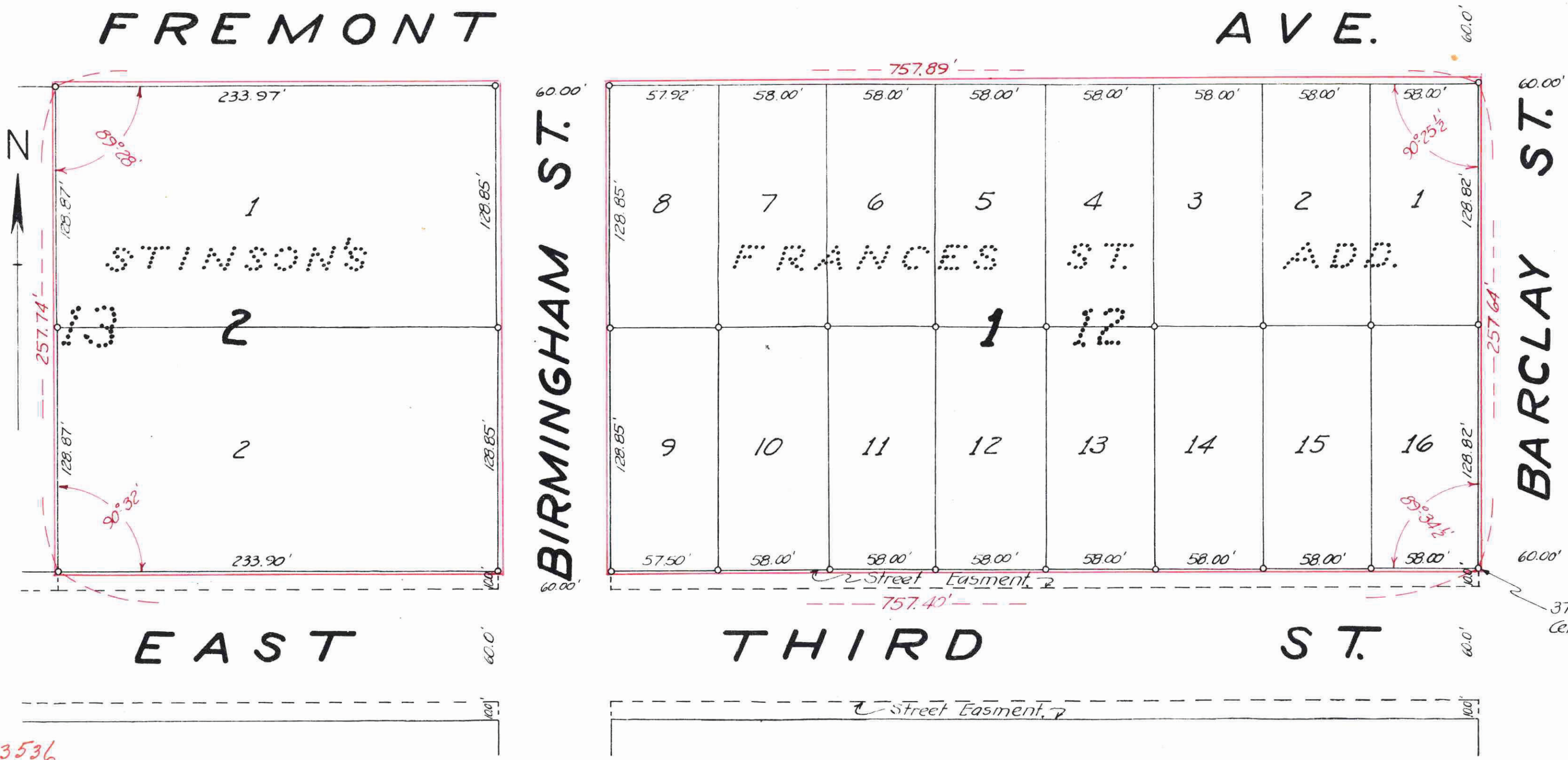


EASTVIEW ADDITION S.T. PAUL MINN.
