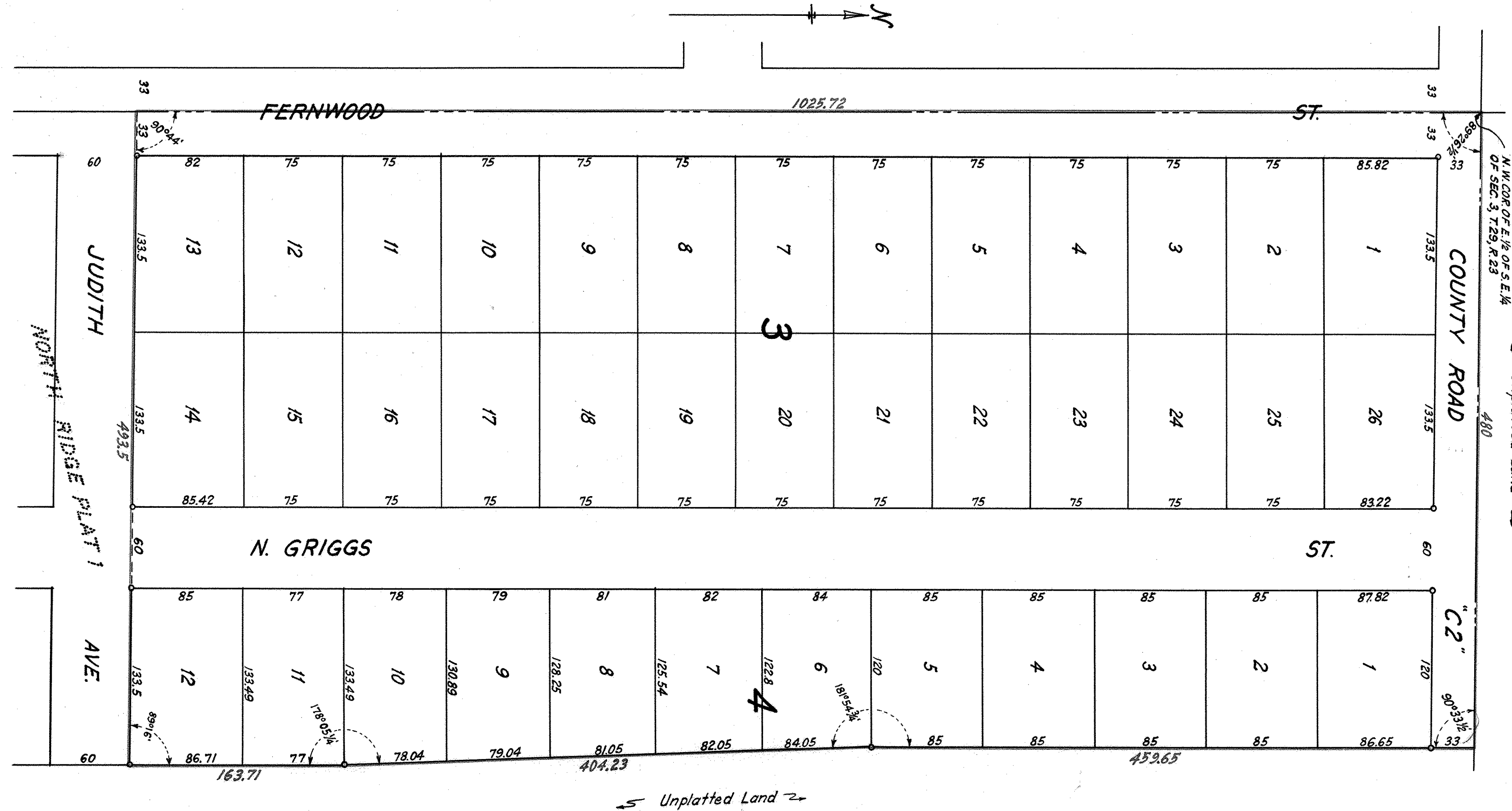


NORTH RIDGE PLAT 2
