

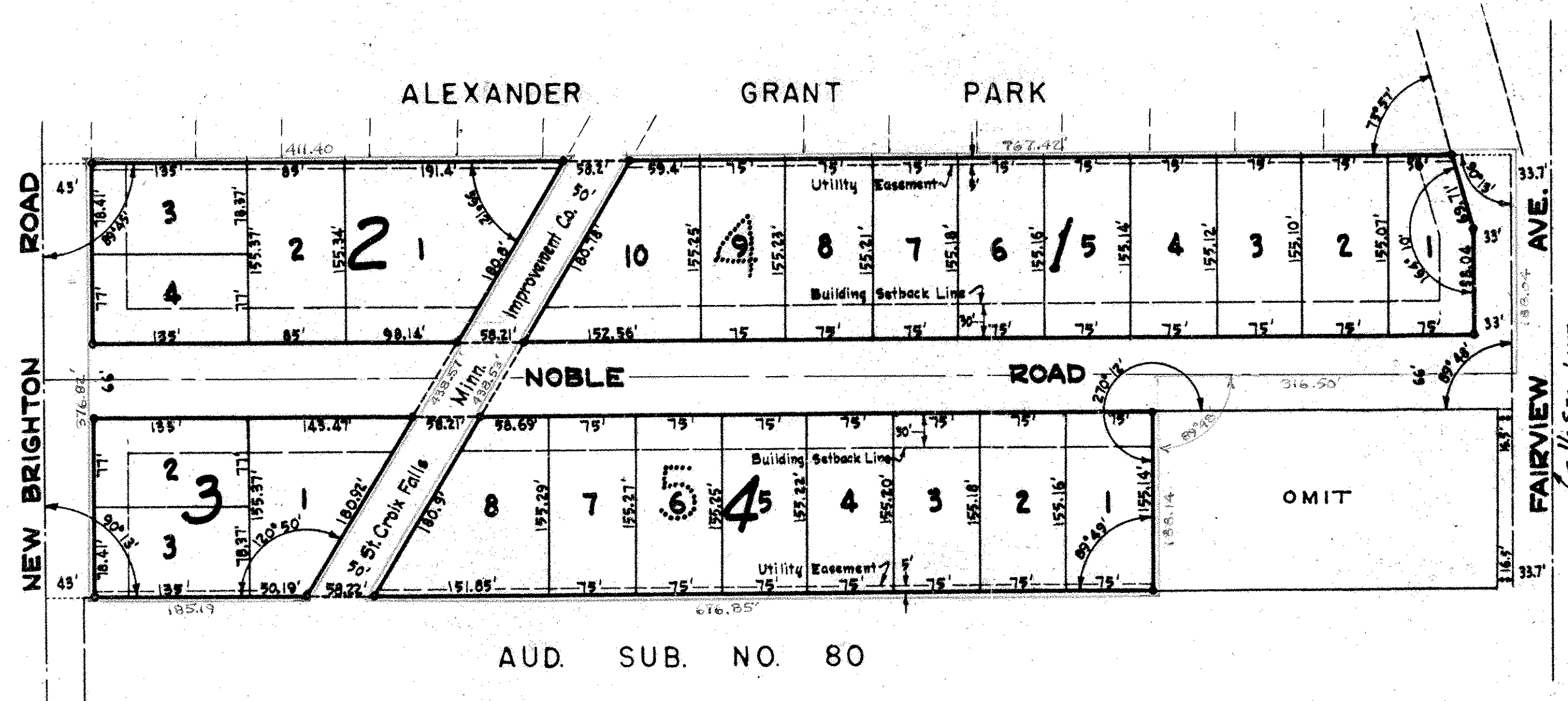
# ELMS ADDITION
