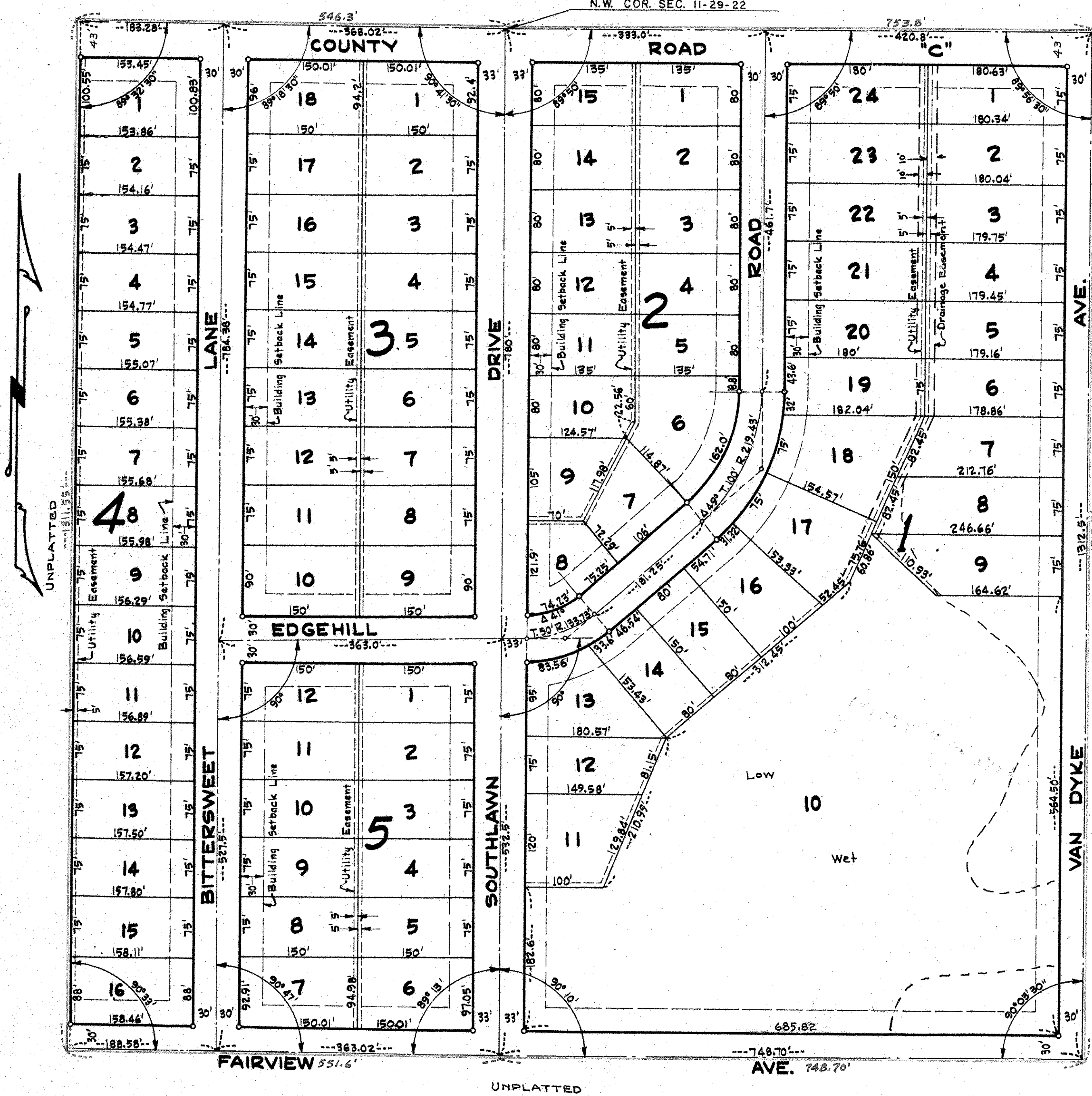
NEW CANADA TOWNSHIP
