

This is to certify that Robin Hood Construction Co., a Minnesota corporation, owners of that part of the Northeast one-quarter (N.E. 1/4) of the Southeast one-quarter (S.E. 1/4) of Section Twenty-nine (29), Township Twenty-nine (29), Range twenty-three (23), Ramsey County, Minnesota described as follows: - Beginning at the intersection of the East line of said Section twenty-nine (29) with the Northern right of way line of the Northern Pacific Railway, said point being Four hundred and seventy (470) feet South of the East 1/4 corner of said Section 29; thence Northwesterly along said Right of Way line eleven hundred and one and eighty one-hundredths (1101.80) feet to a point; thence Southwesterly at right angle to said Right of Way line a distance of thirty (30) feet to a point; thence Southeasterly and parallel with said Right of Way line a distance of one hundred thirty four and thirty-nine hundredths (134.39) feet to a point; thence on a curve to the right with a radius of three hundred thirty-nine and sixty-two hundredths (339.62) feet a distance of two hundred seventy eight and seventy-three hundredths (278.73) feet to the point of intersection with a line one hundred fifty (150) feet Southerly from measured at right angles and parallel with the above mentioned Right of Way line; thence Northwesterly and parallel with the above mentioned Right of Way line a distance of twenty five and seventy-three hundredths (25.73) feet to the intersection with the Easterly line of the Minnesota Transfer Addition, St. Paul Minnesota; thence South along said Easterly line eight hundred fifty one and seventy-three hundredths (851.73) feet to a point one hundred twenty five (125) feet North of the South line of said N.E. 1/4 of the S.E. 1/4 of said Section 29; thence Southeasterly one hundred seventy-six and twenty-six hundredths (176.26) feet to a point in said South line of said 1/4 section distant one hundred twenty five (125) feet east of the east line of said Minnesota Transfer Addition; thence East along said South line six hundred fifty seven and eight hundredths (657.08) feet to the Southeast corner of said 1/4 section; thence North along the East line of said 1/4 section eight hundred forty one and sixty-five hundredths (841.65) feet to place of beginning, have caused the same to be surveyed and platted and hereafter known as 'MARTIN CAPPS' ADDITION' as shown by this plat and hereby dedicate to the public and for public use forever all streets and roads as shown.
