

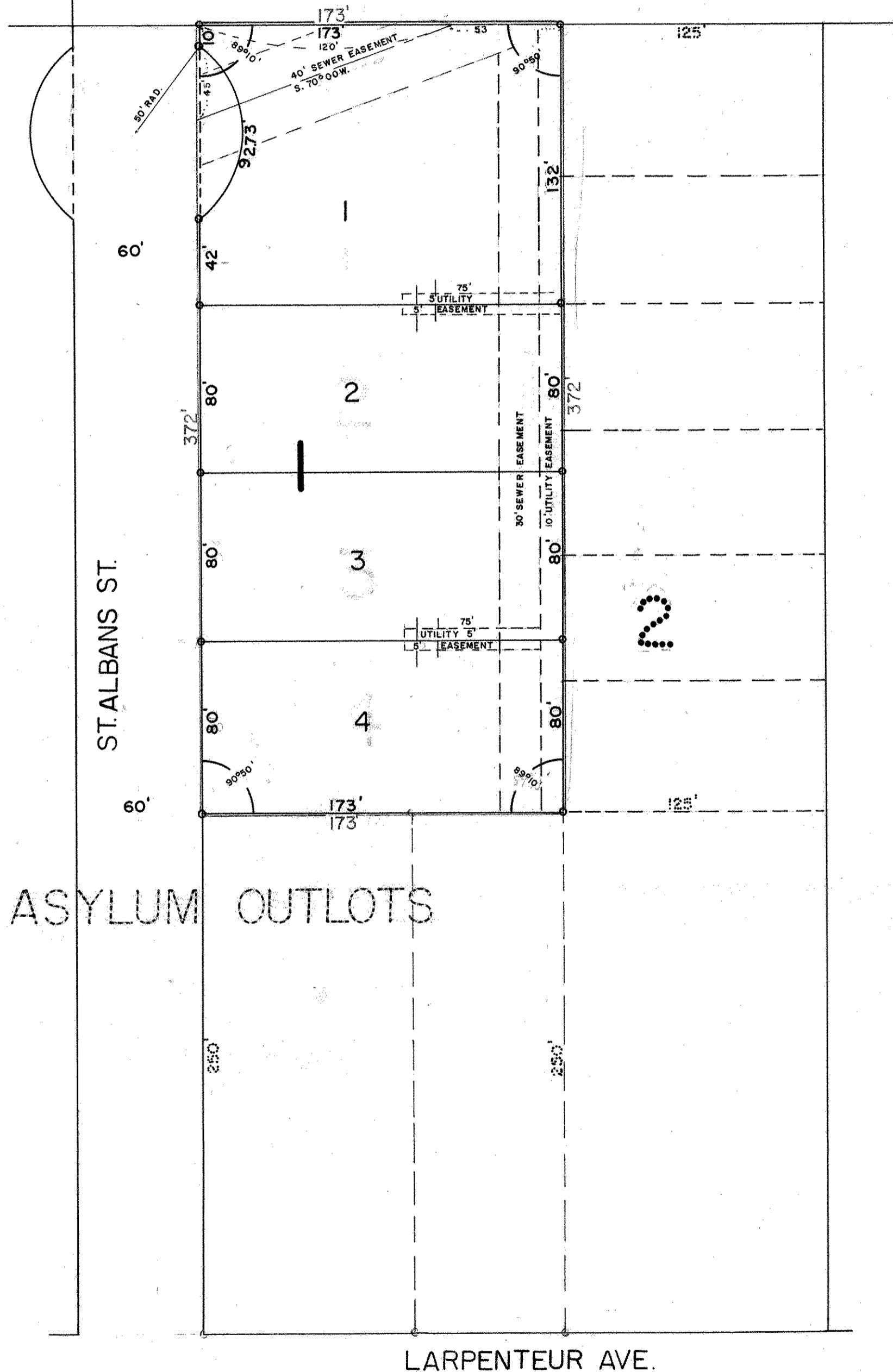
FLEMING'S FIRST ADDITION
