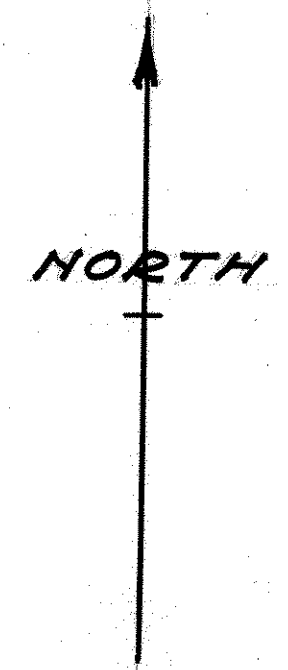
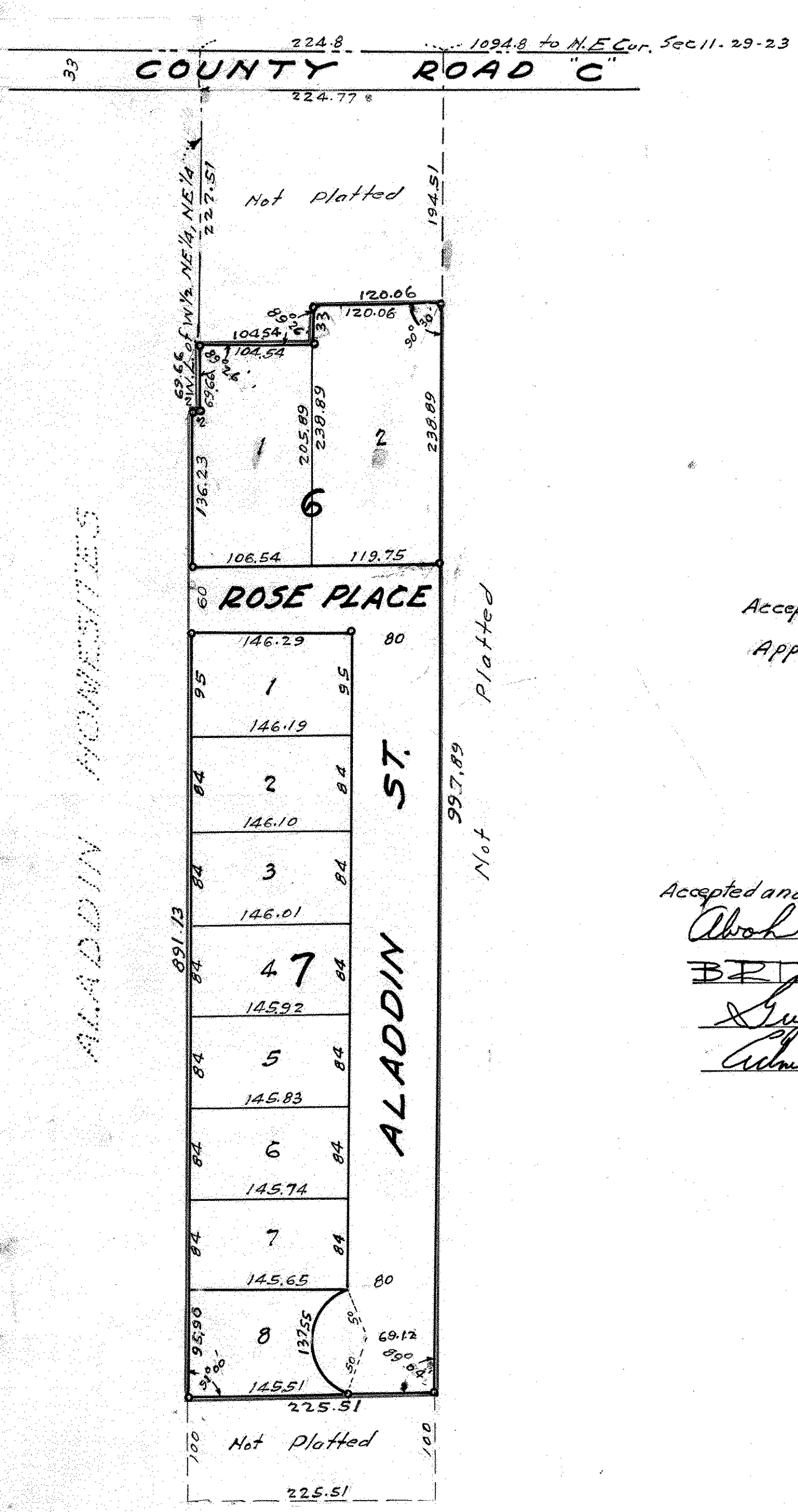


# ALADDIN HOMESITES NO 2
