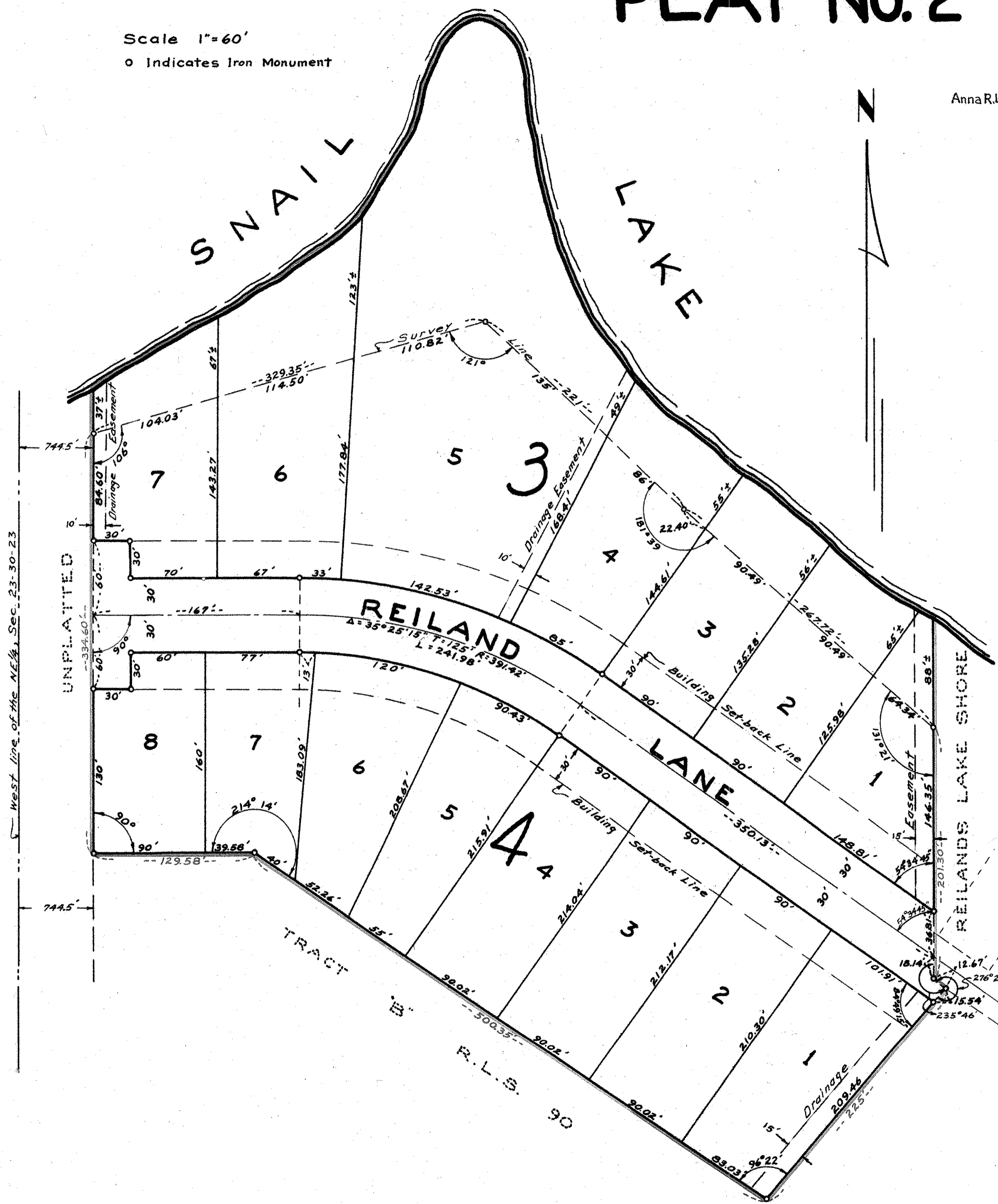


# BAKEN ADDITION
