Edmund Rice proprietor of "Edmund Rice first addition to St Paul" situated as follows: beginning at the center of Section 29 Township 29 north of range 22 west of the fourth principal meridian from said center running west along quarter section line eighteen hundred and fifteen feet thence South thirteen hundred and two feet to the South line of the North half of the South West quarter of said section thence East along said South line eighteen hundred and fifteen feet to the South East corner of said North half of South West quarter thence North along the quarter Section line thirteen hundred and three and a third feet to the place of beginning. Contains fifty five acres of land. do hereby certify that I have caused the same to be surveyed into lots as indicated on this plat to the end that the same may be recorded and I do hereby give the streets therein named for public use.
