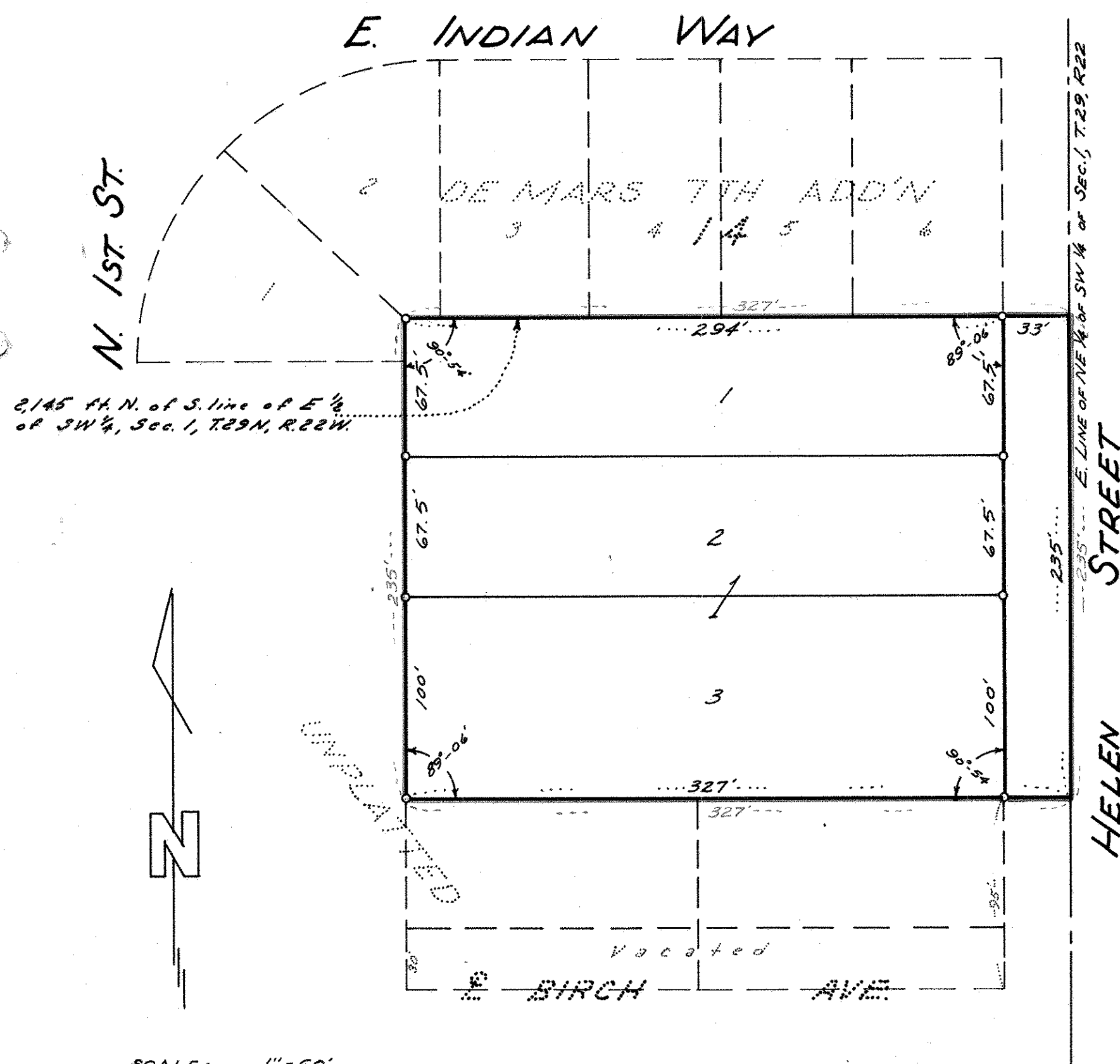


SWANSON ADDITION NORTH ST. PAUL, MINNESOTA
