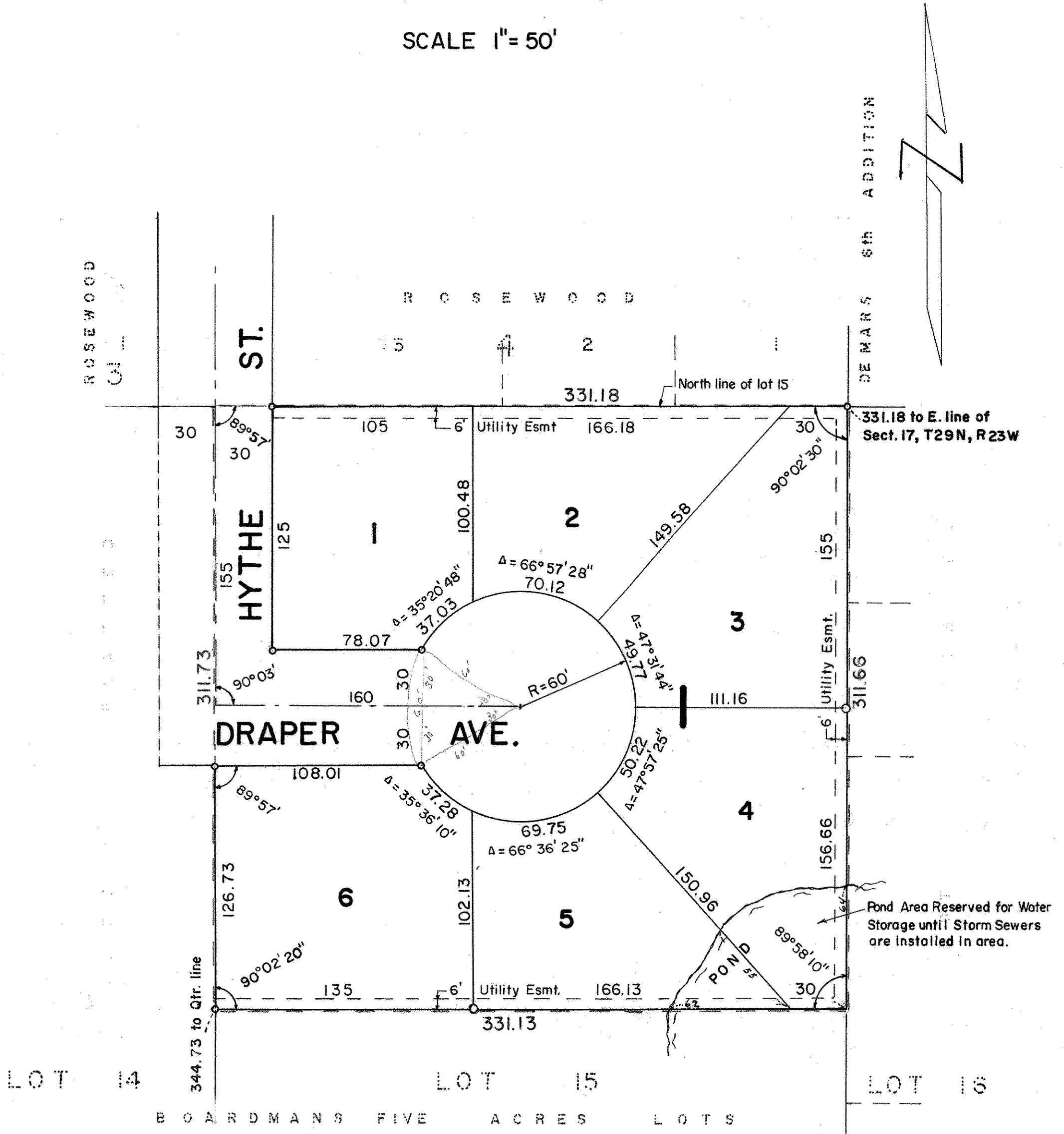


ROSEDALE ADDITION NO. 3
