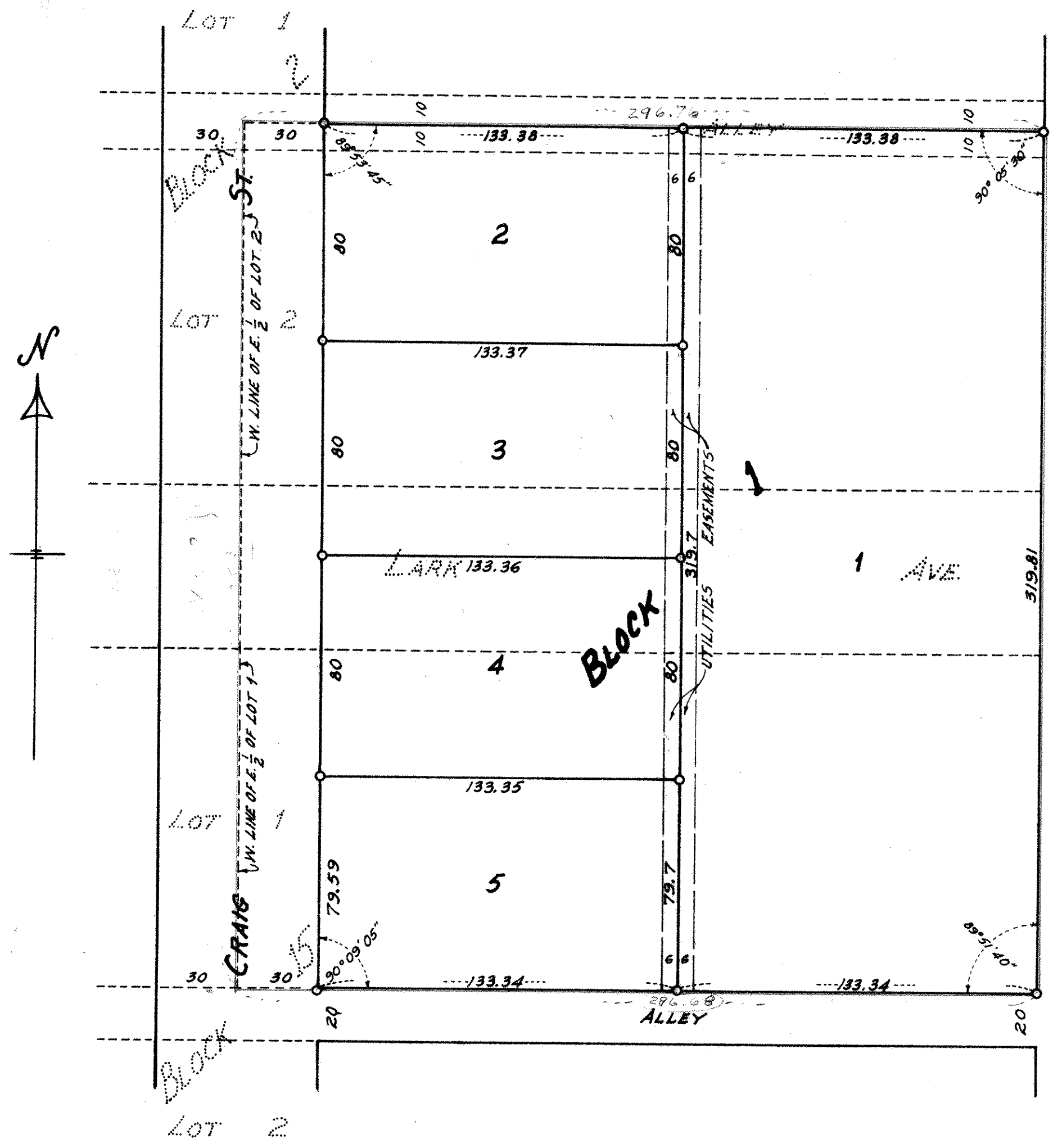


BELISLE'S FIRST ADDITION
