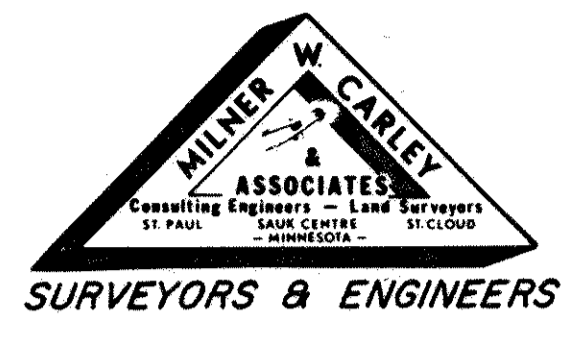


SOLLIE'S ADDITION

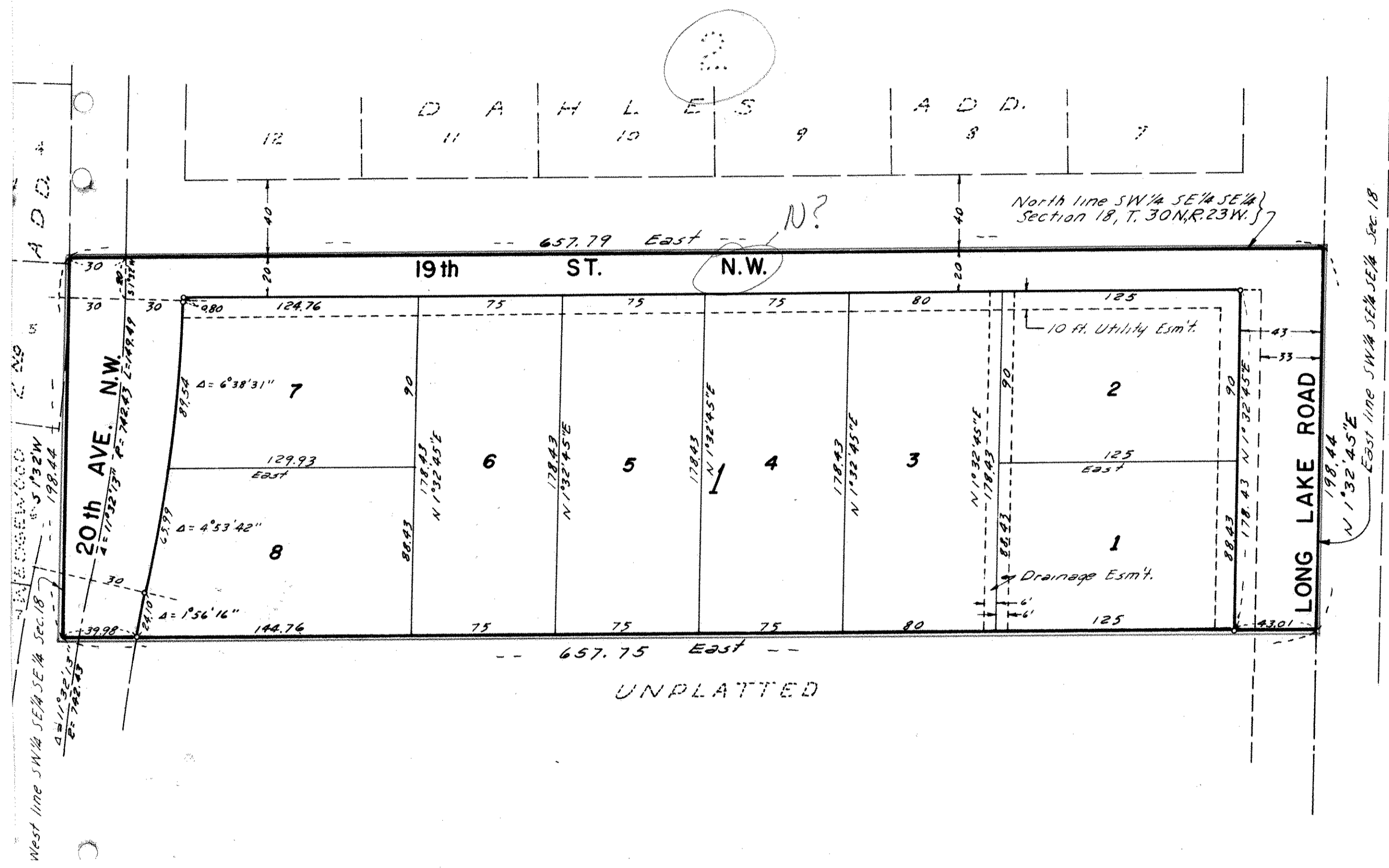
VILLAGE OF NEW BRIGHTON
