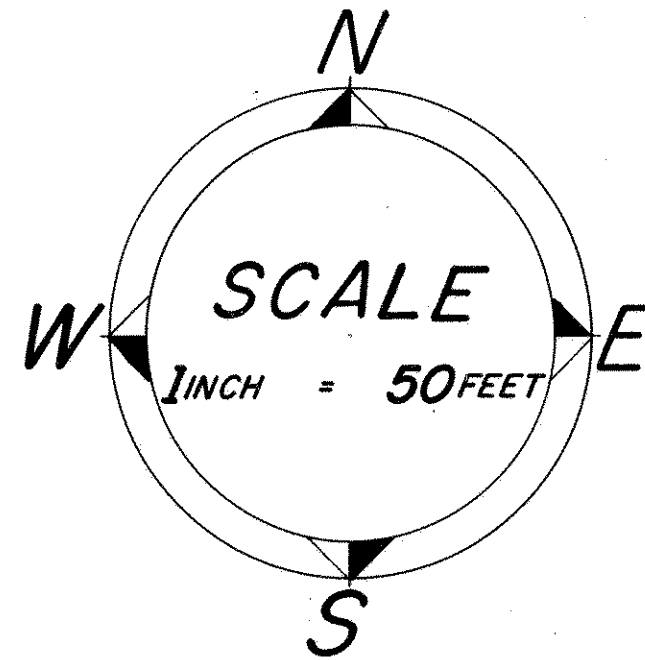
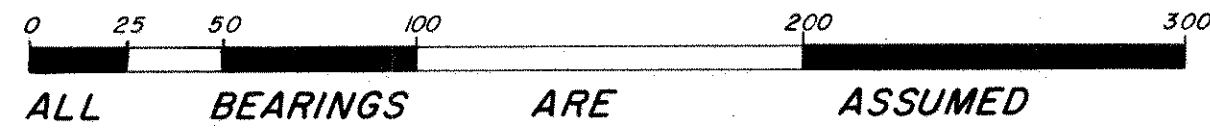
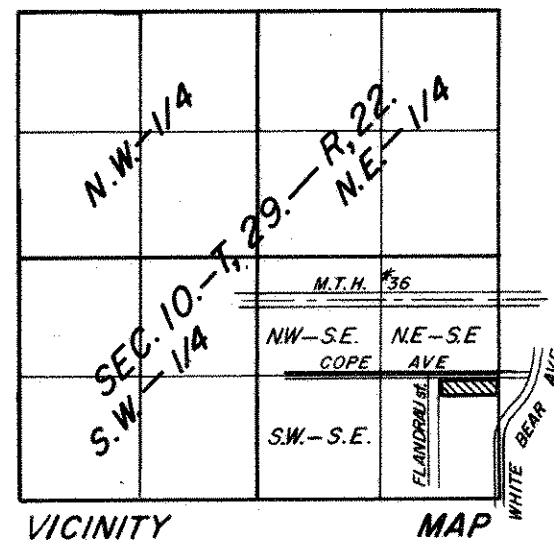


# JOHNSON'S OFFICE PARK
