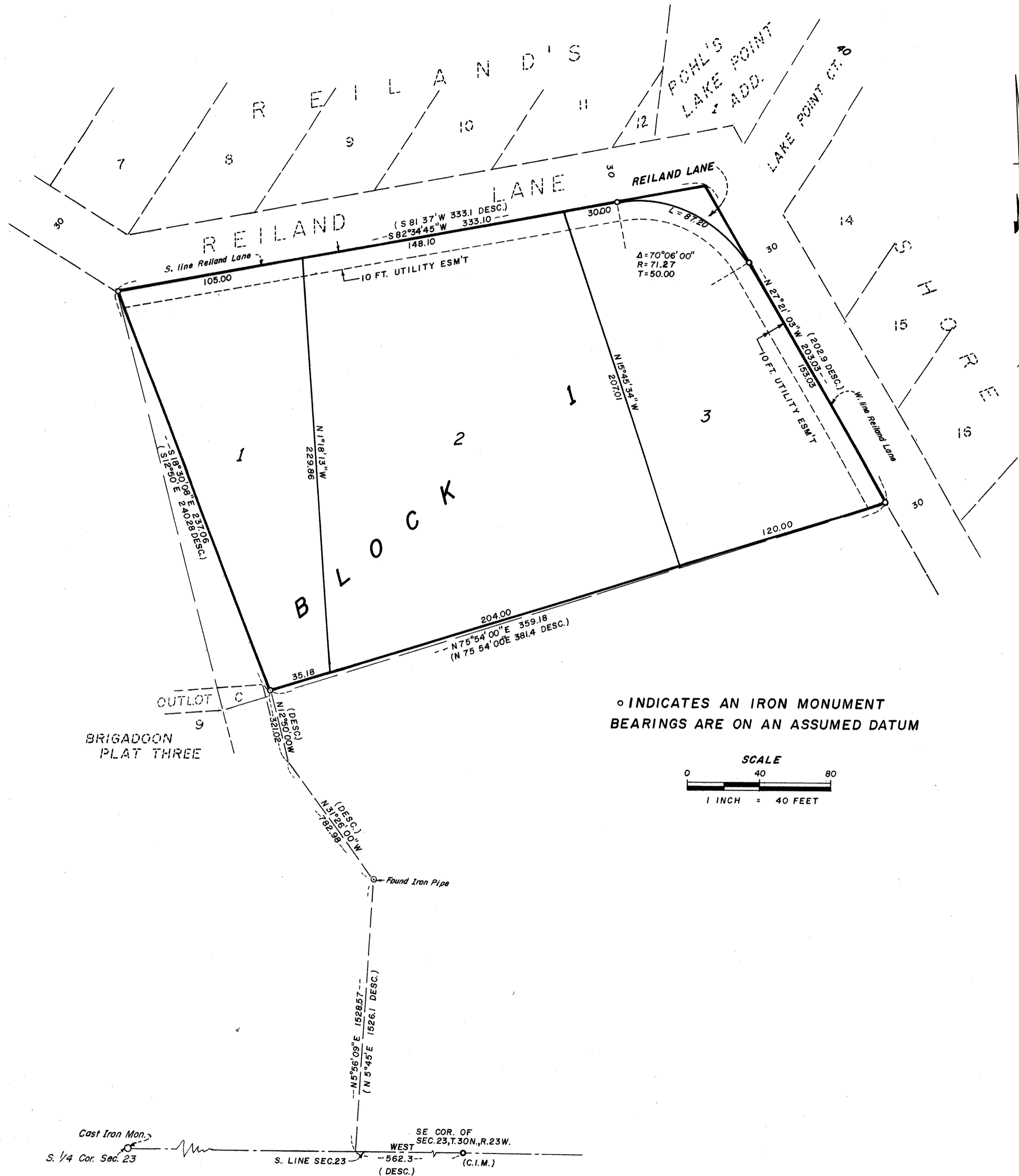


LAPP ADDITION



Know All Persons By These Presents that Charles J. Lapp and Roberta G. Lapp, husband and wife, owners and the Twin City Federal Savings and Loan Association, a United States corporation, mortgagee of the following described property situated in the City of Shoreview, Ramsey County, Minnesota:

That part of Government Lot 5, Section 23, Township 30 North, Range 23 West, described as follows: Commencing at the Southeast corner of said Section 23; thence West along the South line of said Section a distance of 562.3 feet to a point; thence North 5° 45' East a distance of 1526.1 feet to an iron pipe; thence North 31° 26' West a distance of 782.98 feet; thence North 12° 50' West a distance of 321.02 feet to a point, this point being the point of beginning of the land to be described; thence North 75° 54' East a distance of 381.4 feet to the Westerly line of Reiland Lane; thence Northerly along said Westerly line of Reiland Lane a distance of 202.9 feet to the Southerly line of Reiland Lane; thence South 81° 37' West along the Southerly line of Reiland Lane a distance of 333.1 feet to an iron pipe; thence South 12° 50' East a distance of 240.28 feet to the point of beginning, containing 1.74 acres, more or less, according to the United States Government Survey thereof.

Have caused the same to be surveyed, platted and known as LAPP ADDITION and do hereby dedicate to the public for public use forever the lane and utility easement as shown on the plat.

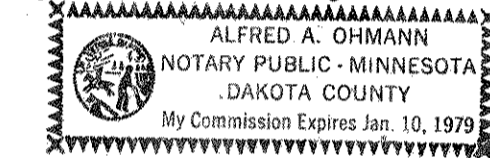

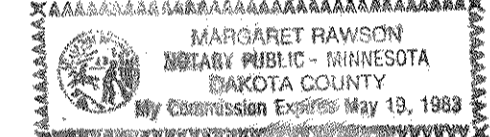

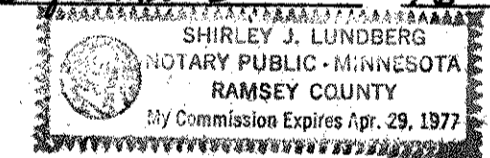
