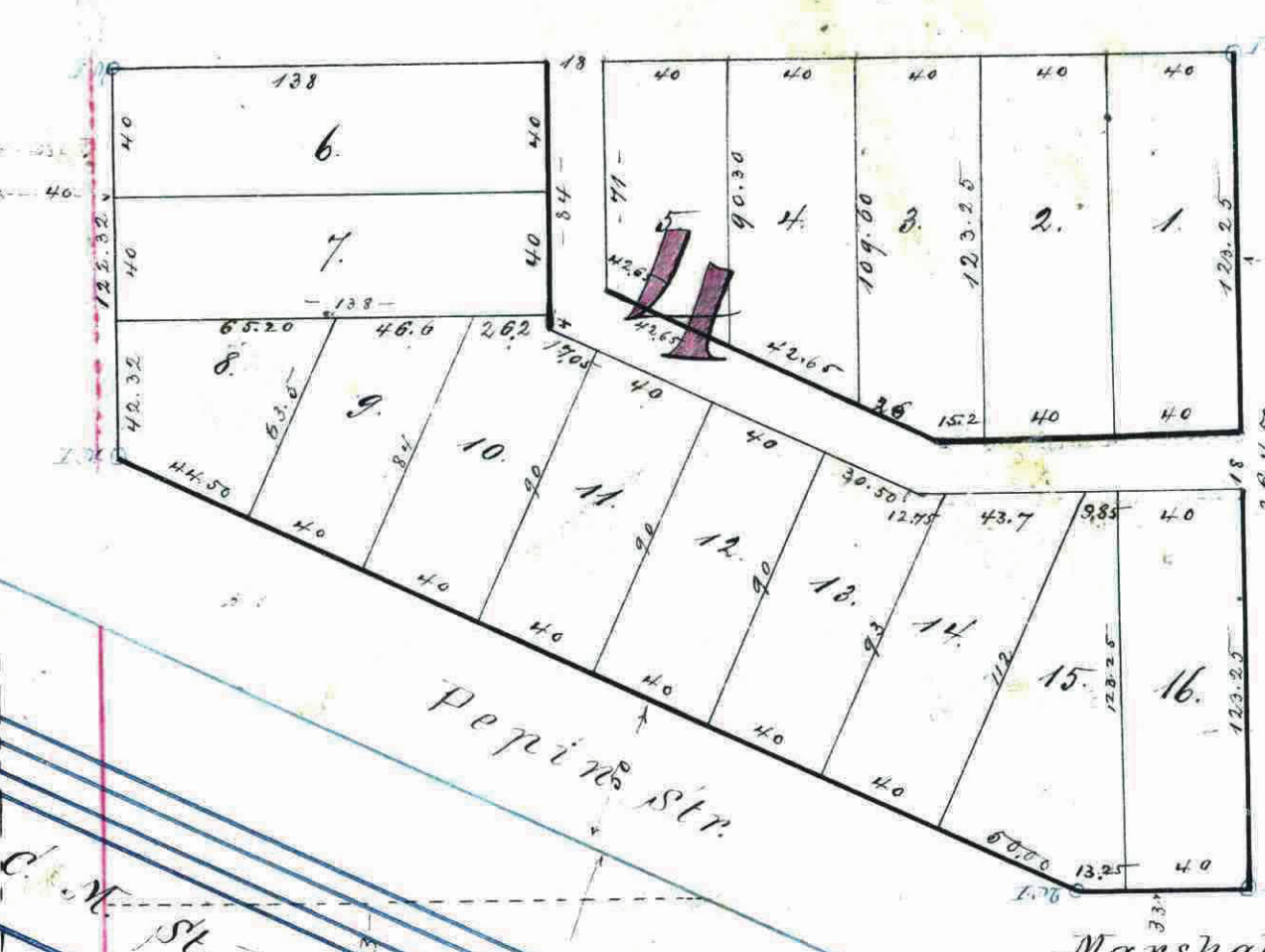
Rondo Str
