

Parcel I. Lots 57, 58 and 59, except the Southerly 10 feet of Lot 57, and also except that part of the West 235.32 feet which lies Southerly of a line drawn perpendicular to the Westerly line of said Lot 59, 314 feet Northerly of the Southwest corner of Lot 57A, all in Oak Crest, Ramsey County, Minnesota.

Parcel 2.
