Township 30 North, Range 23 West, lying North and Northeast of lines described as follows: Beginning at a point distant 770 feet North of the South line of said Southeast Quarter measured on a line running North at right angles to said South line from a point thereom distant 620 feet East of the Southwest corner of said Southeast Quarter: thence running East and parallel to said South line a distance of 908, 59 feet; thence Southeasterly with a Southwesterly included angle of 126 degrees 37 minutes for a distance of 267, 20 feet; thence Southerly with a Southwesterly included angle of 156 degrees 08 minutes a distance of 110 feet to a point in a line running 50 feet Northwesterly from and parallel to the Northwesterly line of Lake Emily Addition: thence Southeasterly on a Northwesterly extension of the Northeasterly line of Lot 7. Lake Emily Addition to the Northwesterly corner of said Lot 7; and lying Westerly of said Northwesterly line of Lake Emily Addition; and lying Southerly of lines described as follows: Beginning at the Northwesterly corner of said Lake Emily Addition; thence running Southwest at an angle of 30 degrees 52 minutes to said Northwesterly line of Lake Emily Addition for a distance of 328, 4 feet; thence Northwesterly to a point on the center line of Victoria St. distant 964 feet Southwest from the Southwest corner of Lake Emily Heights, Ramsey Co., Minn., measured on said center line lying Southeasterly of a line running Northeasterly parallel to said center line of Victoria St. from the first afore described point of beginning to an intersection with last described line running Northwesterly, except that part beginning at the Southwest corner of said Lot 6.
